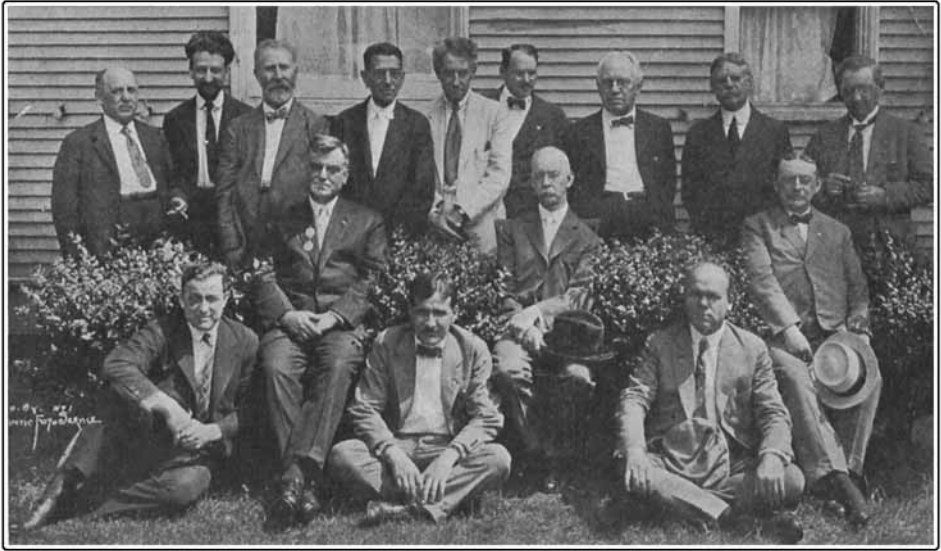

THE COMMITTEE OF REVISION OF THE NATIONAL FORMULARY.

It is fitting that an expression of appreciation be given in the JOURNAL OF THE AMERICAN PHARMACEUTICAL ASSOCIATION of the work which is represented by the National Formulary V. Only those who have assisted in revisions of the Standards can fully realize the task of the revisers. It requires time, study and perseverance to render efficient service on such a committee and certainly all of the members have measured up to the standard implied by *efficient service*. Perhaps no distinction should be made, and there is no thought of pointing to anyone as preferred above others, but the members know that during the years in which the revision was carried on the Chairman had to give somewhat more time than other members, and this did not grow less during the period just prior to the completion of the edition. The Committee has produced a Standard which American pharmacists may well have pride in, and which is deserving of the approval of the medical profession in general. The N. F. V will become official July 1.

That time has passed since the completion of the N. F. IV and its successor is shown by the group picture on the opposite page and the one in the March number of the JOURNAL, p. 160. It is pleasing to note that there has been no change in the membership of the Committee selected for the revision of the National Formulary in 1919, and that death has not entered the ranks.

The Committee has been assisted by able and willing co-workers of related professions and pharmacists, as participants in an undertaking which exhibits a disinterestedness of a group that is rather difficult to match. The members have faithfully and in like spirit carried on the work of their predecessors. They have served medicine in its various branches, the related professions, departments of the U. S.
