## WHY A CONSIDERATION FEE?

Publish or perish are familiar words and the meaning is clear. Publish if you want to qualify for a raise, a promotion, tenure, or a new position. Publish as many papers as possible from each research project because it is the number of papers that is important. Publish or perish is familiar now; publish until scientific journals perish is becoming familiar.

I have listened to your problems with budgets, grants, and reviewers who do not recognize how important it is for your paper to be published. Now will you take a minute and listen to mine?

Last year the cost of publishing the Journal was approximately \$45,000 greater than Journal income. On January 1, 1978, there was an 8% increase in the cost of printing, and there has been a 20% increase in the cost of paper. The number of Journal subscriptions is steadily decreasing as libraries stop multiple subscriptions and institutions stop paying for employee subscriptions. Approximately 40,000 people read the Journal; less than 10,000 subscribe. It may be less expensive to make photocopies of two or three articles of particular interest than to subscribe, but it violates the Journal copyright. Most importantly, it directly cuts into the primary source of income upon which the Journal is dependent for its operating revenue. Three out of four people reading this issue will not read from personal copies. One out of 20 reprint requests to authors will be filled with reprints obtained with perfectly valid institution purchase orders that the institutions then refuse to honor or will pay only after repeated billing and collection efforts. Page charges are not paid for approximately 40% of the articles published in the Journal, although it would appear that publication costs should be an integral part of a research budget.

In an effort to reduce Journal losses and offset some of the expense of considering manuscripts for publication, a nonrefundable \$25.00 consideration fee is now required for all manuscripts submitted to the Journal. If the manuscript is published, page charges will be reduced by \$25.00, the full amount of the consideration fee. Clearly, the consideration fee is an expense only for those authors whose manuscripts are not of acceptable quality or whose sponsoring institutions require them to publish but refuse to accept any responsibility for publication expense. In addition to reducing publication losses, the manuscript consideration fee should improve the quality of manuscripts submitted to the Journal on the basis that authors would not pay the fee if, in their own opinion, their manuscripts are of marginal quality.

Who receives the most benefit from the publication of papers? It cannot be the reader because 75% of Journal readers are unwilling to pay reasonable subscription costs for personal copies; it cannot be the Journal since we operate at a deficit and do not even recoup publishing costs. The major benefit must accrue to authors and their sponsoring institutions because even a publish or perish paper brings recognition and a certain prestige to the authors and their sponsors. If readers are not willing to pay subscription fees to read the articles, and authors are being forced to publish for their professional survival, it appears that authors and their sponsors should be willing to share some of the responsibility for publication expense. This is exactly what is happening in many cases.

Many authors and their sponsoring institutions are supporting the consideration fee, recognizing that (a) it is not an additional expense since it is subtracted from page charges, (b) it may help reduce the backlog of manuscripts, making faster publication possible, and (c) an effort is being made to contain Journal losses arising from manuscripts from sources that are unwilling to assume any publication expense responsibility. There are, of course, other journals that will publish these latter papers now, but they have the same problems as  $J.\ Pharm.\ Sci.\ Unless$  authors, readers, and journals begin working out solutions to their mutual problems now, publish until the scientific journals perish will become a grim reality.
