Hydrocortisone Stability in Ethanol

In reference to my paper¹ "Effect of Vehicle and Other Active Ingredients on Stability of Hydrocortisone" and the recent comments by Chen², I would like to report that hydrocortisone is very stable in alcohol. In my experience of about 8 years, heating the sample in alcohol on a hot plate just to boiling has never caused any stability problem.
