## Journal of Pharmacy and Pharmacology Notice to Contributors

THE JOURNAL OF PHARMACY AND PHARMACOLOGY reviews and reports all aspects of the sciences concerned with the discovery. detection, evaluation, safety, development and formulation of drugs and medicines, and welcomes original contributions relating to such research.

Original research papers or review articles are accepted on the understanding that they are subject to editorial revision, that their content has not been published elsewhere and that in consideration of acceptance of a text for publication the copyright of the said text is assigned to the Journal of Pharmacy and Pharmacology. Research involving human subjects requires the approval of an appropriate ethical committee.

Contributions. Contributions to the Journal can only be accepted if submitted in a form suitable for electronic processing (diagrams and photographs are currently excepted from this rule). It is not necessary to submit a diskette with the original submission, but Authors must be aware that an electronic version will be required if the paper is accepted for publication. Hence, Authors are advised to prepare typescripts using either PC or Macintosh versions of the more popular wordprocessors (WORD, WORDPERFECT, WORDSTAR, WORDPRO). Accepted authors will be asked to provide the diskette with versions in ASCII code in addition to the original wordprocessed version and a new hard-copy version. In preparing Tables, use the "tab" facility to set up columns rather than the dedicated systems for tables found in most word processor packages. Otherwise the following instructions for preparing texts for submission on hard copy will apply

Contributions from Japan should be sent to Professor A. Tsuji, Department of Pharmaceutics, Kanazawa University, Takara-machi 13-1, Kanazawa 920, Japan. All other contributions should be sent to The Editor, Journal of Pharmacy and Pharmacology, I Lambeth High Street, London SE1 7JN, United Kingdom.

**Text.** Authors should consult a CURRENT issue of the Journal and conform to the typographical conventions, use of headings, lay-out of tables, and citation of references. Texts must be typewritten on sheets not larger than 220 × 320 mm (9 × 13 inches) with a minimum margin of 30 mm (1 $\frac{1}{4}$  inch). The typescript and one copy should be sent along with name(s) of the contributor(s), the name and address of the laboratory where the work was done and a shortened title (not more than a total of 50 letters and spaces). The presentation adopted should be that best suited to the clear exposition of the subject matter. A structured abstract should be included, in the form of three (unnumbered) paragraphs setting out the rationale for the study, results, and conclusions based on the findings.

**References.** All citations in the text must appear in the reference list, and vice versa. Unpublished work should not be included in the list unless accepted for publication.

In the text the reference should appear as either: ... Brown (1987) described ... or ... as described previously (Brown & Green 1986). When there are three or more authors, use Brown et al. If the year is the same for several references, identify these with a, b, c etc. e.g. Brown (1985a,b,c), both in the text and in the reference list.

In the reference list, arrange the reference in the order: name(s) (all), date, title of article, serial title, volume, first and last page numbers, with NO underlining thus: Brown, B., Green, G. (1986) The effects of dyes on flexible films. J. Pharm. Pharmacol. 3: 990-995. References are then listed alphabetically under the first author's surname, but if there are several references to three or more authors with the same first author, arrange these chronologically regardless of the alphabetical order of surnames other than the first. These 'alphabetic-chronological' references should be placed after references to Brown alone or to Brown & X. Alphabetize names beginning with de, De, Van, von, etc., strictly according to the spelling of the prefix, e.g., McLoud is alphabetized under MCLO ..., not under MacL or Loud. Serial titles should be abbreviated in accordance with ISO 833. ANSI Z39.5 (1969), and BS 4148 (1970, 1975) (these standards are compatible with each other) or with lists (such as Index Medicus or the BIOSIS List of Serials) based on the principles set out in those standards. Oneword titles are never abbreviated.

References to books should be as follows: Flower, R. J., Moncada, S., Vane, J. R. (1985) Analgesicantipyretics and anti-inflammatory agents: drugs employed in the treatment of gout. In: Gilman, A. G., Goodman, L. S., Rall, T. W., Murad F. (eds) The Pharmacological Basis of Therapeutics, 7th edn. Macmillan, New York, pp. 674–715.

Tables (for each copy of the text) should be typed on separate sheets, their headings should briefly describe their content and they should be understandable without reference to the text. They should not be ruled.

Illustrations. These should be kept to the minimum number necessary for the proper understanding of the subject matter. Two of each are required, one prepared as described below, the other a copy suitable for submission to a referee. The initial dimensions should be chosen to allow for a reduction of at least one-half and not more than one-quarter of the original size. (Most illustrations in the Journal are 5-7.5 cm, 2.0-3.0 inches, in width.) Any symbols used must be legible after such reduction in size. Photographs should be selected to allow for reduction to a similar extent. Lettering and numbering should be inserted lightly and clearly in pencil. Curves based on experimental data should carry clear and bold indications of the experimentally determined points, which should be marked by using only open or closed circles, diamonds, triangles or squares. Legends for illustrations should be kept together on a separate sheet of paper and appended to the typescript. The author's name, the title of the paper and the number of the figure should be written lightly in pencil on the back of each illustration.

**Free Copy**. A copy of the Journal containing the published article is sent to the corresponding author.

**Offprints**. The Journal provides 25 free offprints of the published article and in addition offprints may be purchased in multiples of 50 by completing the order form sent with page proofs.
