Paragraph 1 is incorrect as published in the printed journal and should be replaced with the following:

While the mass spectrum of authentic **9** (Matrix Scientific) does indeed show an ion at m/e 75 (100%), it also features a major ion at m/e 94 (M⁺ – CO, 60%). This rearrangement ion is reminiscent of the ones arising from facile loss of CH2O from the molecular ions of α -ester disulfides [17]. Neither of the mass spectra for $R_t = 6.13$ min or $R_t = 8.55$ min showed an ion for M⁺ –28, which rules out **9** as a component and makes **10** an unlikely structure for $R_t = 8.55$ min. Furthermore, **9** had an R_t of 4.56 min which is entirely inconsistent with the assignment of that structure to the unknown which had $R_t = 6.13$ min.
