$=1.5418 \AA$ ) radiation in $W-2 \theta$ scan mode with $\Delta \omega=(1.0+0.14$ tan $\theta)$ and aperture width of $(3+0.42 \tan \theta)$. Structures were solved by employing direct methods and calculations were performed on a VAX 11/730 computing system using the SDP package. ${ }^{28}$ The packing of both the molecules 16 and 23 is stabilized by van der Waals interactions.

## Computational Details

The constrained-synchronous transition-state structure for the ethylene + butadiene cycloaddition computed at the MNDO level was chosen as the basic model. ${ }^{26}$ The optimized MNDO geometries of NPBQ and DNPBQ were then grafted onto this structure by appropriate replacement of the hydrogen atoms in the ethylene unit. The different dienes studied experimentally were represented by the following three models: 1,3-butadiene, 0 -quinodimethane, and 2,3-dichlorobutadiene. The geometrical modifications to the diene part of the transition-state model was carried out as for the diene with MNDO or standard geometries. The steric interactions between the diene and the norbornyl skeleton of the dienophile were computed by using MM2 parameters. ${ }^{23}$ Since torsional

[^0]effects were not likely to be important in the present systems, only the van der Waals interactions were considered. Therefore, unlike the earlier study, ${ }^{11}$ no partial geometry optimization was carried out. There was also no need to add new parameters to the MM2 force field. The various transition-state model geometries for the top and the bottom face attack in each case as well as the computed nonbonded interaction energies are included as supplementary material.

# $\pi$-Bonding in Four-Coordinate Aluminum Aryloxide Compounds

#### Abstract

The interaction of AIMe ${ }_{3}$ with the substituted phenols 2,6-di-tert-butyl-4-methylphenol (BHT-H), 2,6-diisopropylphenol (DIP-H), and 2,4,6-trimethylphenol (MesOH) in the presence of pyridine (py) or 3,5-dimethylpyridine ( $3,5-\mathrm{Me}_{2} \mathrm{py}$ ) leads to the formation of mono, bis, and tris aryloxide compounds. The molecular structures of AlMe ${ }_{2}$ (BHT)(py) (3a), AlMe(OMes) $)_{2}\left(3,5-\mathrm{Me}_{2} \mathrm{py}\right)(8 \mathrm{~b})$, and $\mathrm{Al}(\mathrm{DIP})_{3}(\mathrm{py})(7 a)$ have been determined by X-ray crystallography. The Al-O distances are shorter and $\mathrm{Al}-\mathrm{O}-\mathrm{C}$ angles larger than usually found for aluminum alkoxides. The presence of a $\pi$-type interaction between the aryloxide ligands and the four-coordinate aluminum centers is proposed to account for the structural results. The tendency of aluminum alkoxide and aryloxide compounds to maximize their coordination number by associating to give aggregates containing tetrahedral and octahedral centers is well-documented. ${ }^{1}$ The use, however, of the sterically hindered aryloxide derived from 2,6-di-tert-butyl-4-methylphenol (BHT-H, from the trivial name butylated hydroxytoluene) results in the isolation of monomeric aryloxide compounds of aluminum. ${ }^{23}$ The X-ray structural determination of $\mathrm{AlMe}(\mathrm{BHT})_{2}$ (1) has been reported, ${ }^{4}$ and it confirms the monomeric nature of this compound. The short $\mathrm{Al}-\mathrm{O}$ distances [average 1.686 (2) $\AA$ ] and large $\mathrm{Al}-\mathrm{O}-\mathrm{C}$ angles [average $143.6(2)^{\circ}$ ] in 1 are consistent with the presence of $\pi$-bonding between the aryloxide oxygens and the vacant aluminum $\mathrm{p}_{z}$ orbital ( $z$ perpendicular to the $\mathrm{AlO}_{2} \mathrm{C}$ plane). This bonding scheme is compatible with the commonly accepted concept that the presence of $\pi$-bonding to a group III element requires a trigonal planar coordinatively unsaturated metal center. We have recently reported, however, that $\pi$-bonding may also be

[^1]present between oxygen and aluminum in four-coordinate complexes. ${ }^{5}$

The presence of a short $\mathrm{Al}-\mathrm{O}$ distance $[1.736$ (5) $\AA$ ] and a large Al-O-C angle [164.5 (4) ${ }^{\circ}$ ] in the X-ray structure of $\mathrm{AlMe}_{2^{-}}$

(BHT) $\mathrm{PMe}_{3}$ (2), ${ }^{5}$ where neither a vacant aluminum p orbital nor an energetically accessible aluminum d orbital is available for $\pi$-bonding, led to our proposal that $\pi$-donation from the oxygen lone pair orbitals to the Al-C and Al-P $\sigma$ antibonding orbitals is present. The gas-phase photoelectron spectrum of 2 supports $\pi$-donation from an oxygen $p$ orbital of the phenoxide ligand into the Al-P $\sigma^{*}$ orbital. ${ }^{6}$

In an attempt to further explore this chemistry we have studied the use of less sterically demanding phenoxides. We have found, however, that phosphines are not sufficiently basic to cleave the aryloxide bridged dimers presumably formed on the addition of phenols to $\mathrm{AlMe}_{3}{ }^{7}$. We have therefore investigated the use of pyridine ( py ) and 3,5 -dimethylpyridine ( $3,5-\mathrm{Me}_{2} \mathrm{py}$ ) as Lewis bases.

We report here the synthesis and structural characterization of a series of monomeric, four-coordinate aluminum aryloxide compounds, $\mathrm{AlMe}_{3-x}(\mathrm{OR})_{x} \mathrm{~L}\left(x=1,2,3 ; \mathrm{L}=\mathrm{py}, 3,5-\mathrm{Me}_{2} \mathrm{py}\right)$. The structures of these compounds are consistent with the presence of $\pi$-bonding between oxygen and the four-coordinate aluminum center.

## Results and Discussion

Addition of 1 equiv of py to an equimolar mixture of $\mathrm{AlMe}_{3}$ and BHT-H in pentane at room temperature results, after the removal of all volatiles, in the formation of $\mathrm{AlMe}_{2}$ (BHT)py (3a) and $\mathrm{AlMe}(\mathrm{BHT})_{2} \mathrm{Py}$ (4a), in a 7:3 ratio. A recent NMR study by lttel et al. ${ }^{4}$ of the species present in an equimolar solution of $\mathrm{AlMe}_{3}$ and BHT-H showed that two disproportionations occur in solution (eqs 1 and 2).

The formation of a mixture of 3 a and 4 a is in contrast to the analogous reaction with $\mathrm{PMe}_{3}$, where $\mathrm{AlMe}_{2}(\mathrm{BHT}) \mathrm{PMe}_{3}$ is the only isolated product. ${ }^{5}$ This difference is indicative of the reduced basicity and increased steric bulk of $\mathrm{PMe}_{3}$ as compared with py. Compound 3 a is isolated in pure form by sublimation from the mixture; $\mathbf{4 a}$ is best prepared directly by the reaction of 1 with py. Recrystallization of 3a or 4a can be accomplished without disproportionation.

Attempts to carry out similar reactions with the less sterically demanding 2,6 -diisopropylphenol (DIP-H) resulted in the formation of an inseparable mixture of $\mathrm{AlMe}_{2}$ (DIP)py (5a) and $\mathrm{AlMe}(\mathrm{DIP})_{2} \mathrm{py}(6 \mathrm{a})$. Interaction of $\mathrm{AlMe}_{3}$ with 3 equiv of DIP-H in pentane followed by the addition of an excess of py results in

the isolation of $\mathrm{Al}(\mathrm{DIP})_{3} \mathrm{py}(7 \mathrm{a})$. It should be noted that attempts to prepare $\mathrm{Al}(\mathrm{BHT})_{3}$ have been unsuccessful. Further reduction in the steric bulk of the phenoxy ligand to 2,4,6-trimethylphenol ( MesOH ) allows the isolation of both $\mathrm{AlMe}(\mathrm{OMes})_{2} \mathrm{py}(8 \mathrm{a})$ and $\mathrm{Al}(\mathrm{OMes})_{3} \mathrm{py}(9 \mathrm{a})$.

The $3,5-\mathrm{Me}_{2} \mathrm{Py}$ complexes ( $\mathbf{3 b}-\mathbf{5 b}, 7 \mathrm{~b}-9 \mathrm{~b}$ ) can be prepared by analogous routes. Compound $\mathbf{6 b}$ can be separated from 7 bb by repeated fractional crystallization. All new compounds have been

fully characterized by 1 R and ${ }^{1} \mathrm{H}$ and ${ }^{13} \mathrm{C}$ NMR spectroscopy. The molecular structures of $\mathbf{3 a}, 7 \mathrm{a}$, and $\mathbf{8 b}$ have been determined by X-ray crystallography and are shown in Figures 1, 2, and 3, respectively. Selected bond lengths and angles are given in Tables 1-111. The structures consist of discrete monomeric units. As was observed for the structure of $\mathrm{AlMe}_{2}$ (BHT) $\left(\mathrm{PMe}_{3}\right)_{\text {, }}$, the geometry around each aluminum is highly distorted from tetrahedral, with the angles associated with the pyridine ligands being the most acute. The similarity in aluminum coordination geometries in these compounds is illustrated by comparing the sums of interligand angles not associated with the pyridine nitrogen [346.6 (7) ${ }^{\circ}(3 \mathrm{a}), 345.3(10)^{\circ}(8 \mathrm{~b})$, and $343.7(6)^{\circ}(7 \mathrm{a})$ ]. The similarity in the geometry around the aluminum is surprising in view of the vastly different steric requirements expected for the different number of phenoxide ligands and the range of substituents on the phenoxide.

The Al-C bonds in 3a $[1.956$ (6), 1.964 (6) $\AA$ ] and 8 b [1.946 (10) $\AA$ ] are in the range observed previously for aluminum-methyl compounds ( $1.90-2.01 \AA$ ). ${ }^{8}$ The Al-N bond distances are within the range previously reported for aluminum-nitrogen bonds (1.88-2.09 $\AA$ ). ${ }^{9}$ It is noteworthy, however, that the $\mathrm{Al}-\mathrm{N}$ bond in 3 a [1.993 (5) $\AA$ ] is slightly longer than that found in $\mathbf{8 b}$ [1.961 (7) $\AA$ ] and 7 a [ 1.957 (3) $\AA$ ], in accord with Lewis acidity and the opposite of what would be expected if steric effects predominated.

In the structure of $\mathbf{3 a}, 7 \mathbf{7}$, and $\mathbf{8 b}$ the $\mathrm{Al}-\mathrm{O}-\mathrm{C}$ angles [140.6 (6) -156.1 (3) ${ }^{\circ}$ ] are much larger than usually observed for main-group alkoxides, although they are in the range found for those transition-metal alkoxide complexes where significant $\mathrm{p} \pi-\mathrm{d} \pi$ bonding is present. ${ }^{10}$ In addition the $\mathrm{Al}-\mathrm{O}$ distances [1.702 (4)-1.740 (4) $\AA$ ] are short compared to the normal range ${ }^{11}$ of $1.8-2.0 \AA$. We have previously proposed ${ }^{5}$ that the short Al-O distance and large $\mathrm{Al}-\mathrm{O}-\mathrm{C}$ angle found in the structure of $\mathrm{AlMe}_{2}(\mathrm{BHT})\left(\mathrm{PMe}_{3}\right)$ were due primarily to $\pi$-donation from the oxygen lone pair, $\mathrm{p}_{z}$, perpendicular to the phenoxide ring into the $\pi$-acceptor $\sigma$-antibonding molecular orbital, $2 \mathrm{e}_{x}$ (I)..$^{12}$ This proposal has been confirmed by gas-phase photoelectron spectroscopy. ${ }^{6}$

The orientation of the phenoxide ring in $3 a$ is essentially the same as that in 2. The $\mathrm{Al}-\mathrm{O}$ distance $[1.740(4) \AA$ ] is comparable to that in $2[1.736(5) \AA]$; however, the Al-O-C angle is more acute, $156.1(3)^{\circ}$, suggesting a reduced $\pi$-interaction from the aryloxide ligand. The reduction in the $\mathrm{Al}-\mathrm{O}-\mathrm{C}$ angle between 2 and 3a may be due to the larger electron donor ability of pyridine, as compared with $\mathrm{PMe}_{3}$, which would regulate the effective $\pi$-donation of the aryloxide. Alternatively, the $2 \mathrm{e}_{x}-\mathrm{p}_{x}$ orbital overlap (I), which presumably has the greatest influence over the bond angle, is greater when the $2 \mathrm{e}_{x}$ orbital is primarily Al-P $\sigma^{*}$, as in 2, rather than Al-C $\sigma^{*}$, as in 3a. Despite the decrease in $\mathrm{Al}-\mathrm{O}-\mathrm{C}$ angle between 2 and 3 a it is clear from the short $\mathrm{Al}-\mathrm{O}$ distance that the presence of $\pi$-bonding is nearly independent of the ligands around aluminum.

The Al-O distances in 7 a a and $\mathbf{8 b}$ [1.702 (4)-1.722 (4) $\AA$ ] are comparable to those for the monoaryloxide compounds, 3a. The $\mathrm{Al}-\mathrm{O}-\mathrm{C}$ angle, however, is reduced for 7a and $\mathbf{8 b}$ [140.6 (6)-145.8 $(6)^{\circ}$ ], suggesting a reduction in $\pi$-bonding. It should be noted that the $\mathrm{Al}-\mathrm{O}-\mathrm{C}$ bond angles in $\mathbf{7 a}$ and $\mathbf{8 b}$ are similar to those found for 1,4 the structure of which is consistent with $\pi$-bonding between the lone pairs co-planar with the aromatic ring on each alkoxide, and the vacant $\mathrm{p}_{z}$ orbital on aluminum.

The $\mathrm{Al}-\mathrm{O}-\mathrm{C}$ angle would be more dependent on the magnitude of $\pi$-donation from the lone pair perpendicular to the phenoxide ring, $\mathrm{p}_{z}$, (I), rather than the lone pair parallel, $\mathrm{p}_{y}$, (II), to the phenoxide ring. It is unlikely, however, that the Al-O distance would vary significantly between either form of $\pi$-bonding.

If in $\mathbf{7 a}$ and $8 \mathbf{b}$ only one oxygen lone pair on each aryloxide is involved in $\pi$-bonding, as in 1 , then the aryloxide ligand would orient so as to attain a maximum orbital overlap between the oxygen p -orbital type lone pair and the $\mathrm{Al}-\mathrm{X} \sigma^{*}$ orbitals. The orientation of one aryloxide (O1) in $\mathbf{8 b}$ is such that one of the oxygen lone pairs is suitable for donation into the $\mathrm{Al}-\mathrm{N} \sigma^{*}$ orbital. The second aryloxide ( O 2 ) is oriented for $\pi$-donation into the $\mathrm{Al}-\mathrm{Ol} \sigma^{*}$ orbital. Two of the aryloxides in 7a are oriented in a similar fashion to those in $\mathbf{8 b}$ with the third aryloxide ( O 1 ) oriented for $\pi$-donation into the $\mathrm{Al}-\mathrm{O} 3 \sigma^{*}$ orbital.

The $\mathrm{Al}-\mathrm{O}-\mathrm{C}$ angles in 7a and 8 b [140.6(6)-145.8(6) ${ }^{\circ}$ ] are most probably due primarily to the interaction between the aryl $\pi^{*}$ orbital and the lone pair perpendicular to the aryl ring. Such an interaction has been used to explain the large $\mathrm{Si}-\mathrm{O}-\mathrm{C}$ angles present in silicon aryloxides where no $\pi$-interaction is observed between the oxygen and silicon. ${ }^{13}$

If $\pi$-donation is present from the aryloxide oxygen to the four-coordinate aluminum center, then ${ }^{27} \mathrm{Al}$ NMR should be a useful technique to augment X-ray crystallographic data. The ${ }^{27} \mathrm{Al}$ NMR shifts of the aryloxide compounds cover a wide range, $\delta 140-47 \mathrm{ppm}$. Within this range, however, there are three distinct groups: the mono aryloxide $\delta 134-140 \mathrm{ppm}$; the bis aryloxides $\delta 69-72 \mathrm{ppm}$; and the tris aryloxides $\delta 47-50 \mathrm{ppm}$. The upfield shift of the ${ }^{27} \mathrm{Al}$ NMR signal with the substitution of a methyl group by an aryloxide is counter intuitive based on the relative electronegativity of the substituents. This trend is consistent, however, with the presence of $\pi$-donation of electron density onto the aluminum. The similarity in the ${ }^{27} \mathrm{Al} \mathrm{NMR}$ shifts for 7 Fa ( $\delta$ 48 ppm ) and $9 \mathrm{a}(\delta 50 \mathrm{ppm})$ is an indication that the steric hinderance at the ortho position on the phenol rings has little effect on the aluminum center.

In conclusion all spectroscopic and structural results for these systems are consistent with $\pi$-bonding between the aryloxide ligands and four-coordinate aluminum centers involving an overlap between the $\mathrm{Al}-\mathrm{X} \sigma^{*}$ and the oxygen lone pairs.

## Experimental Section

Microanalyses were performed by Oneida Research Services, Inc., Whitesboro, NY. Melting points were determined in sealed capillaries and are uncorrected. IR spectra ( $4000-700 \mathrm{~cm}^{-1}$ ) were recorded on a Perkin-Elmer 137 grating spectrometer as Nujol mulls. NMR spectra, in $\mathrm{C}_{6} \mathrm{D}_{6}$, were recorded on Bruker AM-250 $\left({ }^{1} \mathrm{H}\right)$, Bruker AM-500 $\left({ }^{13} \mathrm{C}\right)$, and Varian $300\left({ }^{27} \mathrm{Al}\right)$ spectrometers [ $\delta$ in parts per million relative to

$\mathrm{SiMe}_{4}\left({ }^{1} \mathrm{H}\right.$ and $\left.{ }^{13} \mathrm{C}\right)$ and $\left.\mathrm{Al}\left(\mathrm{H}_{2} \mathrm{O}\right)_{6}{ }^{3+}\left({ }^{27} \mathrm{Al}\right)\right]$. All manipulations were carried out under nitrogen. Solvents were dried, distilled, and degassed prior to use.

2,6-Di-tert-butyl-4-methylphenol (BHT-H), 2,4,6-trimethylphenol ( MesOH ), and 2,6-diisopropylphenol (DIP-H) (Aldrich) were sublimed prior to use. Trimethylaluminum ( 2.0 M solution in hexane) was used as supplied (Aldrich). Pyridine and 3,5-dimethylpyridine (Aldrich) were distilled prior to use and stored over molecular sieves. $\mathrm{AlMe}(\mathrm{BHT})_{2}$ was prepared as previously described. ${ }^{5}$
$\mathrm{AlMe}_{2}$ (BHT)py (3a). To a solution of BHT-H ( $2.00 \mathrm{~g}, 9.1 \mathrm{mmol}$ ) in pentane ( 60 mL ) was added $\mathrm{AlMe}_{3}$ in hexane ( $4.5 \mathrm{~mL}, 9.1 \mathrm{mmol}$ ). After the solution was stirred for 4 h, py $(0.75 \mathrm{~mL}, 9.23 \mathrm{mmol})$ was added. The resulting solution was stirred for 2 h and reduced to dryness under vacuum. AlMe $\mathbf{2}_{\mathbf{2}}$ (BHT)(3,5-Me $\mathbf{M e y}^{\mathbf{p y}}$ ) (3b). The synthesis was carried out in an analogous manner to that of 3 a with BHT-H ( $1.50 \mathrm{~g}, 6.82 \mathrm{mmol}$ ), $\mathrm{AlMe}_{3}$ ( $3.40 \mathrm{~mL}, 6.80 \mathrm{mmol}$ ), and $3,5-\mathrm{Me}_{2}$ py ( $0.78 \mathrm{~mL}, 6.84 \mathrm{mmol}$ ). ${ }^{1} \mathrm{H}$ NMR of the crude reaction mixture indicated that the major impurity was AlMe ${ }_{3}\left(3,5-\mathrm{Me}_{2} \mathrm{py}\right)$. Attempted Synthesis of AIMe(DIP) $\mathbf{2}_{\mathbf{2}}(\mathbf{p y})$ (6a). To a stirred pentane ( 40 mL ) solution of DIP-H $(1.00 \mathrm{~g}, 5.61 \mathrm{mmol})$ at room temperature was added $\mathrm{AlMe}_{3}$ in hexane ( $1.4 \mathrm{~mL}, 2.8 \mathrm{mmol}$ ) via syringe. After 0.5 h py ( $1.0 \mathrm{~mL}, 12.3 \mathrm{mmol}$ ) was added and the resulting solution stirred for 8 h. Removal of the solvent and excess pyridine under vacuum yielded a white powder, the ${ }^{1} \mathrm{H}$ NMR spectra of which indicate a mixture of products. Attempts to purify by fractional crystallization and vacuum sublimation were unsuccessful. Repeating the reaction in toluene also resulted in a mixture. The impurities are $\mathrm{Al}(\mathrm{DIP})_{3}(\mathrm{bpy})$ (7a) and presumably AlMe 2 (DIP)py (5a). Reaction of the appropriate ratio of $\mathrm{AlMe}_{3}$, DIP-H, and py to form 5 a results in a similar mixture.

AIMe(DIP) $\mathbf{2}^{\left(3,5-\mathbf{M e}_{z} \mathrm{Py}\right)(6 \mathrm{~b}) \text {. With use of reaction conditions }}$ analogous to those for 6 a , with DIP-H ( $1.0 \mathrm{~g}, 5.6 \mathrm{mmol}$ ), AlMe ${ }_{3}(1.4 \mathrm{~mL}$, 2.8 mmol ), and $3,5-\mathrm{Me}_{2}$ py ( $0.32 \mathrm{~mL}, 2.8 \mathrm{mmol}$ ), crystallization from pentane/toluene resulted in the formation of crystals of two different forms. One set gave the ${ }^{1} \mathrm{H}$ and ${ }^{13} \mathrm{C}$ NMR of 7 b , and the other set analyzed for $\mathbf{6 b}$. Al (OMes) $)_{3}(\mathrm{Py})(9 \mathrm{a})$. To a pentane ( 40 mL ) solution of MesOH ( 0.50 $\mathrm{g}, 3.67 \mathrm{mmol}$ ) was added $\mathrm{AlMe} \mathrm{M}_{3}(0.61 \mathrm{~mL}, 1.22 \mathrm{mmol})$ via syringe. The resulting solution was stirred for 1 h and then py ( $0.5 \mathrm{~mL}, 6.2 \mathrm{mmol}$ ) was added. The resulting solution, which contained a large quantity of precipitate, was stirred an additional 8 h . After the precipitate settled, the pentane was removed via cannula and the remaining solid dried in vacuo. Crystals were grown from benzene/pentane: yield $0.53 \mathrm{~g}, 85 \%$; mp $134-137^{\circ} \mathrm{C}$; IR 1635 (m), 1360 (sh), 1340 (s), 1305 (sh), 1290 (s), 1255

X-ray Crystallographic Study. A crystal data summary is given in Table IV; fractional atomic coordinates are listed in Tables V-VII. X-ray data were collected on a Nicolet P3 (3a, 8b) diffractometer at room temperature and a Syntex $\mathbf{P} 2_{1}$ (7a) diffractometer, which is equipped with a modified LT-1 apparatus. Laue symmetry determination, crystal class, unit cell parameters, and the crystal's orientation matrix were carried out by previously described techniques. ${ }^{14}$

All data were corrected for Lorentz and polarization effects and placed on an approximately absolute scale by means of a Wilson plot. The systematic extinctions observed for all three determinations were $0 k 0$ for $k=2 n+1$ and $h 0 l$ for $h+l=2 n+1$; the diffraction symmetry was $2 / m$. The centrosymmetric monoclinic space group was $P 2_{1} / n$; a nonstandard setting of $P 2_{1} / c$ [ $C_{2 h}$; No 14] was uniquely defined.

All crystallographic calculations were carried out with either the UCI modified version of the UCLA Crystallographic Computing Package ${ }^{15}$ or the SHELXTL PLUS program set. ${ }^{16}$ The analytical scattering factors for neutral atoms were used through the analysis; ${ }^{17}$ both the real ( $\Delta f^{\prime}$ ) and imaginary ( $i \Delta f^{\prime \prime}$ ) components of anomalous dispersion ${ }^{18}$ were included.

The structures were solved by direct methods (Shelxtl plus) and refined by full-matrix least-squares techniques. Hydrogen atom contributions were included by using a riding model with $d(\mathrm{C}-\mathrm{H})=0.96$ $\AA$ and $U$ (iso) $=0.08 \AA^{2}$. Refinement of positional and anisotropic thermal parameters (isotropic for carbon atoms in $\mathbf{8 b}$ ) led to convergence (see Table IV).
