

A. O. C. S. Committee Appointments

Acting under instruction of the Governing Committee at the New Orleans meeting, your president sent out a letter June 3rd giving the membership the opportunity of volunteering for service upon the committees of the Society, and he feels certain that every member of the Society will feel gratified, as he did, at the fine response to this letter.

Replies were received from considerably more than half of the members, including 24 who graciously advised that they were unable to accept service upon any committee, and 106 volunteered for committee service not including several who failed to write their names on the card that they sent in, making it impossible for us to identify them (so if any members failed to receive appointment, it will probably be because of their having failed to sign their cards).

We should all feel particularly proud that in our Society we have more *working* past presidents than in any organization in the country. All too often, when a man has served as president of other organizations, and feels that he has attained the highest honors, which the Society can give him, he becomes inactive, whereas we have only to look over the list of the A. O. C. S. past presidents to see our hardest and most constructive workers. Just to illustrate, consider the outstanding work which is being done by past presidents Humner, Richardson, Irwin, Trevithick, Vollertsen, Agee, Cluff, Law, Fash, Barrow, Stryker and many others. Certainly there must be something fine and virile about a Society that so inspires its executives to continue to work harder than ever after service.

We wish to personally thank every member for his generous response and we deeply regret that it is impossible to appoint every volunteer upon the particular committee which he designated. We also wish to thank each and every one of the committee chairmen for their generous cooperation, and we particularly appreciate the untiring efforts of the chairman of the Uniform Methods and Planning Committee for his fine work in laying out the objectives and working with the committee chairmen.

It has been decided to appoint an additional committee at this time, to be known as the Color Glass Development Committee, to work with the Color Committee, looking toward improvements and stabilization of color glasses, and it has also been decided to extend the membership committee to include regional solicitation members from the East, from the Middle West, the Southeast, the Southwest, from the Pacific Coast and from Latin American countries.
