ANNUAL BOWLING TOURNAMENT

THE annual bowling tournament of the American Oil Chemists' Society is one of the highlights of the entertainment at Fall meetings. The tourney was held at the newly decorated Bensinger Alleys at 70 West Madison Street, Chicago.

Fifty-seven entries battled for top honors in the competition. Several more would have liked to bowl but were prevented by lack of sufficient alleys. The reservation of a sufficient number of alleys during the bowling season for a one-night tournament is a matter of considerable difficulty and the committee regrets exceedingly that several late arrivals were prevented from bowling by lack of space.

The "Amaizo" team from the American Maize Products Company was back in form this year, rolling high team score and winning another leg on the Amaizo Trophy donated three years ago by Vice-President R. E. Daley of their company. The Amaizos have now won the trophy twice and one more win entitles them to permanent possession of it. Lever Bros. team and Precision Scientific Company's team have each won the trophy once and it is expected that next year will bring a hotter contest than any we have ever had.

Armour Soap Works' team gave the Amaizos a tough contest this

year, taking second honors with a score only 19 pins lower than that of the winners. This team will have to be watched in future competition.
