INNOVATION IN PROGRAM

In an effort to modernize our program and bring our convention procedure into agreement with generally accepted practices, the Governing Board has passed a resolution requesting that all committee reports requiring more than five minutes reading time shall be mimeographed by the Society and distributed to those attending the meeting.

By the use of this device, the reading of long detailed reports will be eliminated and, instead, each Chairman is requested to make an abstract of his report which may be read in about five minutes. In this abstract a brief summary of the work done should be given, together with the conclusions and recommendations. Proposed changes in methods should be described in detail in the abstract.

It is realized that this change is being made at a late date and for this reason those committees who cannot complete their work in time for this new procedure will be permitted to deliver their reports in the old fashion.

It is the belief of the Board that this is a constructive move which will add to the enjoyment of meetings and at the same time afford more time and a better basis for intelligent discussion of each report.
