The banquet will be held in the historic Patio Royal, which is in the Vieux Carre. This building has considerable history attached to it and was the home of Paul Morphy, the world-famous chess player. Leslie George's band has been retained for our entertainment.

A day trip to Baton Rouge for Sunday, May 7th, is proposed. This will take in Louisiana State University, the Capitol, and, if sufficient time is available, the Spillway.

Special arrangements will be made for ladies entertainment. Efforts are being made to include the usual boat ride.

The Patio Royal, where the banquet will be held, is a handsome structure which was erected in 1801 toward the close of the Spanish domination in Louisiana as a combination residence and place of business by Don Jose Faurie, a wealthy merchant of the period. In subsequent years it housed the Banque de la Louisiane, created by Governor W. C. C. Claiborne, then was purchased by the socially prominent Martin Gordon family as a residence. When General Andrew Jackson visited New Orleans in 1928 he was a guest of the Gordons in this home.

Baton Rouge, the capital of Louisiana, is the third city in Louisiana and is located on the first highlands above the mouth of the Mississippi river at the head of deep water navigation. Visiting members should take the trip to this interesting city.
