Meet Your Past President . . .

G. G. FOX ELECTED SIXTH PRESIDENT, 1915

(EDITOR'S NOTE: This is another in the series of sketches on past presidents which Oil & Soap inaugurated with the March, 1946, issue to acquaint new members with past leaders. Previous presidents were Felix Paquin, pro tem in 1909, elected for year 1910; and David Wesson, E. R. Barrow, F. N. Smalley, and G. W. Agee.)

AS sixth president G. G. Fox, one of the vice presidents of Armour and Company, Chicago, Illinois, recalls that back in 1908 a small group of men, interested in the technical development of the cottonseed oil refining industry, met rather informally in Louisville during the convention of the Cottonseed Crushers' Association and discussed the desirability of organizing a chemists' division of the Crushers' Association. The following year the Society of Cotton Oil Analysts was organized with Felix Paquin as first president.

In 1915, when he was elected president, the principal matters of interest were the development of a method for refining cottonseed oil, particularly for settlements and trading rules. A great deal of discussion was given over to methods of reading colors of refined oil, and the check-meal analysis for cottonseed meal was then getting under way. At that time the Society had a small membership, consisting of men employed by the various refiners in the cottonseed oil industry.

His early professional career was begun in a chemical laboratory of Armour and Company but soon expanded into refinery operations, sales, and administration. Mr. Fox reports that he has not been active in the work of the Society for the last 25 years.
