Meetings

The 8th National Chemical Exposition, set for the Chicago Coliseum October 12-15, 1954, will be a center for a series of joint meetings with the Manufacturing Chemists' Association, the Chemical Market Research Association, the Society of Chemical Industry, and the Purchasing Agents' Association. In addition there will be a lecture series by the editors of Industrial and Chemical Engineering, publication of the American Chemical Society, and a meeting of the Chicago section of the A.C.S. at which Walter Reppe, German chemist, will speak.

The third convention of FATIPEC, Federation of Technical Associations of the Paint and Printing Ink Industries in Continental Europe, will be held May 22-27, 1955 in Spa, Belgium. General topic will be Color and Color Matching, Theoretical and Practical Aspects.

The dramatic resurgence of the foreign chemical industry will be discussed at the meeting of the Commercial Development Association on October 7-8, 1954 in Bedford, Pa., at the Bedford Springs hotel. Interest will focus on the transfer of technological know-how as a means of commercializing new developments in international markets.

An invitation pamphlet is now available for the ACHEMA XI exhibition and Congress of Chemical Engineering from the Deutsche Gesellschaft fur Chemisches Apparatewesen, Frankfurt am-Main, Germany, Box W.13. The exhibition will be held May 14-22, 1955 in Frankfurt.

A comprehensive examination of plastic products, their structural, utility, and decorative uses will feature a conference on Plastics in Building, scheduled for October 27-28, 1954 at the National Academy of Sciences in Washington, D. C. The meeting will be the first of its kind and is sponsored by the Society of the Plastics Industry Inc., the Manufacturing Chemists' Association, and the Building Research Advisory Board.

Chemical sessions of the annual convention of the National Safety Council will be held at the LaSalle hotel, Chicago, Ill., on October 18-22, 1954. There will be industry round-table discussions on special problems as well as general topics.

An exhibit of the scientist's tools will be held in the main lobby of the Department of Commerce building September 27 to October 9, 1954 in Washington, D. C., under the sponsorship of the Motion Picture and Photographic Products division of the Department, in cooperation with the Scientific Apparatus Makers Association.

What is believed to be the first cooperative industry-university seminar on cosmetic science in the United States will be held by the Society of Cosmetic Chemists on September 23-24, 1954 at the New York Academy of Sciences, with speakers from New York University, New York Medical College, Rensselaer Poly-technic Institute, and Textile Research Institute as well as from the Atlas Powder Company, Hazelton Laboratories, and Rayette Inc. Maison G. DeNavarre of Detroit is one of the program committee.
