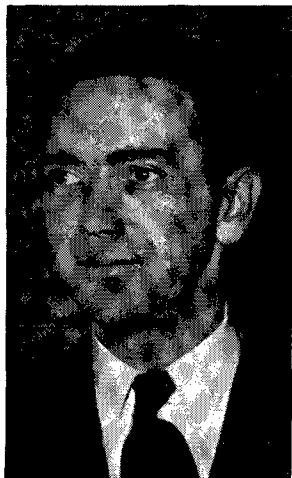

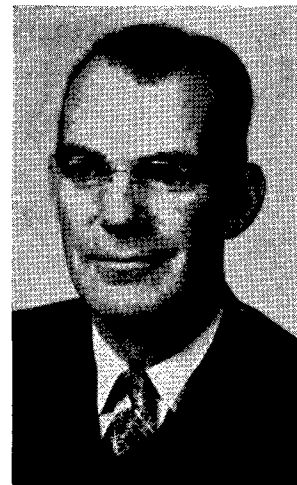
A. F. Kapecki
