The Governing Board of the Society requests approval of these changes, which are intended to make possible more flexibility in the setting of fees, establish an active junior membership classification, set up a policy for deciding a tie vote for any office, make certain changes in procedure for the Referee Examining Board, and bring the amendment on meetings of the Society into agreement with actual practice. Changes in the by-laws are needed to implement the amendments to the constitution.


