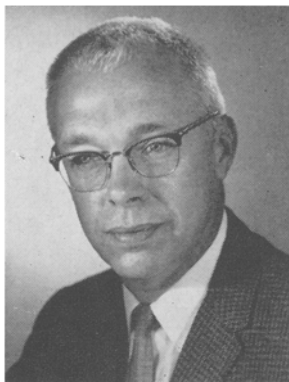

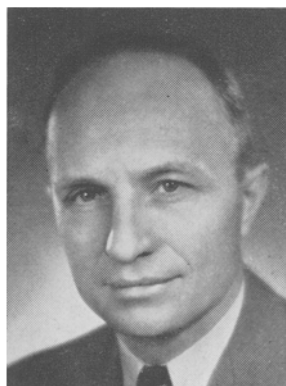

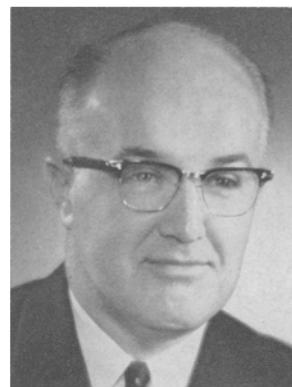

Monday morning, Oct. 15, 1967, the American Oil Chemists' Society will convene the General Assembly of its 41st Annual Fall Meeting at the Pick-Congress Hotel in Chicago. The 38th Annual Meeting, held at the Pick-Congress in 1964, attracted nearly 1,000 scientists from here and abroad, to attend the three-day Technical Program. R. A.
