New Orleans Meeting Draws Record Attendance

Attendance Strong, Interest High

The AOCS welcomed one of the largest groups of registrants in its history to New Orleans last May 8 with guests from almost every state in the Union, as well as representatives from England, Denmark, Iran, Australia, Brazil, Mexico and Canada. With over 950 attending this outstanding Annual Meeting, attendance in Chicago next October is sure to exceed 1,000. The technical program was excellent, with a total of 135 papers presented.

The meeting began with the traditional Sunday evening mixer, made exciting by the presence of well more than the usual number of members and guests. The mood was effervescent. For some, just the change from cold northern to the kinder climates of New Orleans was sufficient to elevate spirits to party pitch. No need for an ice-breaker when the temperature is in the pleasant 80-degree range! On Monday morning several hundred persons attended

the business session which convened in the University Room of the Roosevelt Hotel. R. T. O'Connor, Chairman of the New Orleans Committee, presided. AOCS President C. W. Hoerr called the meeting to order, and The Honorable V. H. Schiro, Mayor of New Orleans, delivered a cordial, official welcome. Minutes of the 57th Annual Meeting were read by the Secretary, J. C. Cowan, and A. F. Kapecki delivered his 14th consecutive report as treasurer of the AOCS.

The President's address, to be found on page 250A of this issue, and the Treasurer's Report, appearing on page 293A,

both attest to the fact that the Society has improved its financial position considerably in the past year. President Hoerr emphasized the need to build membership, as new applications are not being received in proportion to the growth of the field the Society serves.

J. C. Harris, Past President and Head of the Nominating and Elections Committee, announced the newly-elected officers: President, Raymond Reiser; Vice-President, J. C. Cowan; Secretary, G. C. Cavanagh; Treasurer, N. T. Joyner; Members-at-Large, S. S. Chang, Mrs. L. S. Crauer and R. T. O'Connor.

J. P. Harris Receives Honorary Membership

The following is the text of Mr. Hoerr's announcement of the election of J. P. Harris to Honorary Membership in the AOCS:

I regret very much that Mr. Harris was unable to come to New Orleans to be with us this morning. I understand that his wife is quite ill and he felt that he shouldn't leave her at this time. We all hope sincerely for her speedy recovery.

It is entirely fitting and proper that we have elected John P. Harris to Honorary Membership in the Society. He is one of the grand old men of our industry. He is still so active that it surprises me to realize he is approaching his 81st birthday this year.

Mr. Harris graduated from the University of Kansas in 1907 and obtained a Certificate in Chemistry from the Royal Institute of Technology in Charlottenburg in 1909. After several years at Armour and Company and the Phoenix Cotton Oil Company, he became as sociated with the industrial chemical sales division of the West Virginia Pulp and Paper Company and served as manager of their Chicago office from 1926 until his retirement in 1951. Call for Nomination for Fourth AOCS \$2,500 Award in Lipid Chemistry

Sponsored by Applied Science Laboratories

In April 1964 the Governing Board of the American Oil Chemists' Society established the American Oil Chemists' Award in Lipid Chemistry under the sponsorship of the Applied Science Laboratories Inc., State College, Pennsylvania. The first award was presented to Erich Baer, of the University of Toronto, at the AOCS Symposium on "Quantitative Methodology in Lipid Research," which was held at Pennsylvania State University on Aug. 3-7, 1964. The second award was made to Ernst Klenk of the University of Cologne, Germany, at the Fall Meeting held in Cincinnati Oct. 10-13, 1965. The third award was made to H. E. Carter of the University of Illinois, Urbana, at the Fall Meeting held in Philadelphia, Penn. Oct. 2-5, 1966. The award consists of \$2500 accompanied by an appropriate certificate.

It is now planned that the fourth award will be presented at the AOCS Fall Meeting in Chicago, Illinois Oct. 15-18,

Canvassing Committee Appointed

Policies and procedures governing the selection of award winners have been set forth by the AOCS Governing Board. An Award Nomination Convassing Committee for the fourth award has been appointed. Its membership is R. F. Witter, Chairman; R. M. Burton, G. C. Cavanagh, R. T. Holman, and Rodolfeo Paoletti. The function of this committee is to solicit nominations for the fourth award. Selection of the award winner will be made by the Award Committee whose membership will remain anonymous.

Rules

The rules prescribe that nominees shall have been responsible for the accomplishment of original research in lipid chemistry and must have presented the results thereof through publication of technical papers of high quality. Preference will be given to individuals who are actively associated with research in lipid chemistry and who have made fundamental discoveries that affect a large segment of the lipid field. For award purposes, the term "lipid chemistry" is considered to embrace all aspects of the chemistry and biochemistry of fatty acids, of naturally occurring and synthetic compounds and derivatives of fatty acids, and of compounds that are related to fatty acids metabolically, or occur naturally in close association with fatty acids or derivatives thereof. The award will be made without regard for national origin, race, color, creed or sex.

Letters of nomination together with supporting documents must be submitted in octuplicate to Robert F. Witter, Chairman, AOCS Award Nomination Canvassing Committee, Laboratory Improvement Program, National Communicable Disease Center, USPHS, 1600 Clifton Road, N.E., Atlanta, Georgia 30333, before the deadline date of August 1, 1967. The supporting documents shall consist of professional biographical data, including a summary of the nominee's research accomplishments, a list of his publications, the degrees he holds, together with the names of the granting institutions, and the positions held during his professional career. There is no requirement that either the nominator or the nominee be a member of the American Oil Chemists' Society.

Remember the DEADLINE, August 1, 1967.

organized his own company, John P. Harris, Inc., and has since been actively engaged as a sales representative for a number of chemical suppliers.

Mr. Harris joined the AOCS in 1916. This makes him one of our oldest living members. He immediately became active in the Society by serving on a number of committees beginning with his service on the Membership Committee in 1919 and continuing in many capacities to the proper time period. He is still serving as an adviser to the Advertising Committee, which has been one of his continuing interests through the years to see to it that we have sufficient income from advertising sources to cover the expense of our publications. In 1932, he was elected Vice President of the Society and in 1933, he served as President. We are indebted to Jack Harris probably more than to any other member, for keeping the Society going through the difficult depression years. I have heard rumors about his handling of the Society finances which I wish he were here to clarify for us. As I understand it, Jack managed to keep the Society financially solvent through those years, although the sources of sufficient income were not readily apparent to the members. My grapevine informs me that it was suspected that Jack Harris dipped into his own pocket many times to cover Society expenses. The records are not clear on this point so we have no way of knowing just how he did it, but we do know that the Society emerged from the depression in a stronger financial position and with a larger membership than before Jack Harris went into office.

After I notified Mr. Harris of his election to Honorary Membership I received a most pleasant letter from him in which he reminisced about the first meeting of the Society that he attended in New Orleans in 1916, when the Society was yet barely 9 years old. He mentioned that among the members he recalls at this meeting, but he has promised to be at the meeting in Chicago this fall.



plenary lectures. Those lectures will give a review of the present state of knowledge in the various fields and actual

topics which still call for research.

After the technical meeting the participants will visit two great oil plants at the ports of Gdansk and Gdynia and will become acquainted with the work in progress at the Fats Chemistry and Technology Department at the Gdansk Technical University.

in English.

The Bond Award Gold Medal, which honors excellence in both content and delivery of a given presentation in either of the Society's annual meetings, was presented to H. Y. Lew, Chevron Research Company, Richmond, Calif. The winning presentation was made at the 1966 Fall Meeting in Philadelphia, and is entitled, "Acid" Pyrolysis-Capillary Chromatographic Analysis of Anionic and Nonionic Surfactants.

One of the two Honorable Mention Awards in the Bond Award Competition was given to L. D. Williams, of Anderson, Clayton & Co., for his paper, "Distribution of Monoesters Resulting from the Esterification of a Mixture of Glycols and Polyols." An Honorable Mention Award was also given to Sister Paul Michael Slakey, University of Michigan, Ann Arbor, who presented her work on "The Structure of Rat Liver Triglycerides."

Special distinction this year went to A. C. McConnell, Woodson-Tenent Laboratories, Little Rock, Arkansas, who was named winner of both the Smalley Cup and the Barrow-Agee Cup. The Smalley Award honors proficiency in the determination of moisture, oil and nitrogen in the Check Sample Program; the Barrow-Agee cup is presented for the best rating in cottonseed analysis and is sponsored by Barrow-Agee Laboratories, Inc. The person receiving either of these trophies three years in succession retains it permanently.
