



Symposia on Chemistry, Nutrition and Application of High Molecular Weight Lipids

The technical program committee of the 1968 Fall Meeting of AOCs in New York is carefully planning a balanced program to satisfy the interest of all the attendants who are specialized in a wide variety of fields. A total of 15 symposia are being organized. It is hoped that together with the submitted papers, they will cover the progress in all frontiers of fats, oils, and lipids. The technical program committee is now ready to announce a symposium on the chemistry, nutrition and application of high molecular weight lipids. It is organized by Dr. V. K. Babayan of Stokely-Van Camp, Inc. This symposium will include a paper discussing the chemical and biological properties of heated and autoxidized fat by Neil R. Artman of the Procter and Gamble Company; a discussion on the preparation, properties, and application of sugar esters by Reuben O. Feuge of the Southern Utilization Research and Development Division of USDA; a report on the nutritional quality of triglycerides of saturated hydroxy fatty acids by George O. Kohler of the Western Utilization Research and Development Division of USDA, and a timely discussion of the preparation and properties of some short and medium chain length fatty esters of polyglycerols by the organizer of this symposium.

The importance of autoxidation and flavor stability of edible oils are going to be emphasized by a symposium organized by Dr. Rex J. Sims of the General Foods Corporation. This symposium will include speakers such as Dr. A. S. Henick, of the U. S. Army Natick Laboratories, Dr. W. W. Nawar, of the University of Massachusetts, Dr. B. G. Tarladgis, of the International Flavors and Fragrances, Dr. M. Karel, T. P. Labuzza of the Massachusetts Institute of Technology and Dr. E. G. Hammond of Iowa State University. Two additional papers will be presented in this symposium by speakers from abroad. One is going to be presented by Drs. E. Fedeli and G. Jacini of the National Center for Lipochemistry of the National Research Council, Italy, and the other by Drs. U. Pallotta and P. Capella, of the University of Bologna, Italy.

Journal Committee Presents Guide to Authors Regarding Symposia Publication Policies

At the Journal Editorial Advisory Board meeting held on March 31, 1968, in Washington, D. C., T. H. Applewhite presented the following guide in regard to the publication of symposia in the Journal.

General Policies

Papers presented in a Symposium at an AOCs Meeting may be published as a single unit in the Journal. Symposia units will not be published in Lipids. The AOCs reserves first rights of publication on papers delivered at AOCs Meetings. Authors desiring to publish elsewhere must obtain a release from the Editor. Each paper to be published must clearly represent a scientific contribution and meet the quality standards of the Journal. The Editor cannot guarantee that all papers of a unit will be published unless normal standards are met.

The AOCs is unable to provide funds to aid Symposium speakers to attend meetings of the Society. Symposia papers may acknowledge grants in support of attendance of participants.

To expedite unit publication, three copies of Symposia manuscripts will be due and should be delivered to the Symposium chairman at the time of presentation. Arrangements for delayed submission of Symposium manuscripts must be made beforehand with the Chairman. Under any circumstance, submission of a manuscript more than 30 days after the presentation date will disqualify it from consideration as part of the Symposium unit. Such late manuscripts will be considered and processed as regular contributions to the Journal or to Lipids.

An Associate Editor or Editors from the Journal or from Lipids will be assigned prior to the Symposium to assist the chairman in preparing the unit publication. Symposia chairmen who wish unit publication should request this assignment as soon as the list of papers and speakers is arranged.

Papers that are a part of the Symposium unit will be reviewed by qualified persons selected by the Associate Editor. Every effort will be made to preserve the spirit of the group of papers making up a Symposium. Recognizing that Symposia papers often will be reviews, reviews plus original data or completely original works, the Associate Editor assigned will work with the author and reviewers to convey the maximum information covered in a given Symposium.

Brevity

Authors are urged to review the "Plea for Brevity" in the current JAOCs "Guide to Authors." Excessively long or repetitive papers will be returned for modification.

Organization of Papers

Authors should follow the JAOCs Guide to Authors recognizing that Symposia papers may differ significantly from original contributions. Although other requirements under "General Organization of Paper" will not be rigidly enforced, all papers should have Title, Author's Name, Abstract, and Literature References as suggested in the Guide to Authors. Requirements outlined under "Preparation of Manuscript" in the Guide must be met.
