## Nominations Sought AOCS Award of Merit

Nominations are sought for the new Award presentation at the Minneapolis Fall Meeting. The general purpose of the Award is to recognize current achievements, without regard to age of the nominee, and to serve as a stimulus for those working in various AOCS activities. Any or all of the following types of service shall be considered as the basis for the Award of Merit.

- Active productive service to AOCS committee work.
- Marked leadership in technical, administrative, or special committee or Society activities.
- Outstanding activity or service that has particularly advanced the Society's prestige, standing, or interest.
- Any distinguished service to the Society not herein otherwise specifically provided for.

The awards shall be granted by the Board of Directors to any AOCS Member on nomination of a special Award of Merit Committee of five to be appointed annually by the President, with approval by the Board. One member of the committee shall be from the Board of Directors, to serve for one year. The term of office of the other four members shall be staggered, and of two years' duration.

Nominees may be selected by the Award of Merit Committee from members participating in any area of the Society's work.

Provided qualified candidates are available, it is the intent that the awards made annually be distributed among the several areas as outlined above.

All suggestions for the Award of Merit shall be in the hands of the Executive Secretary of the Society for consideration by the Award of Merit Committee not later than July 15, 1969 for presentation to the Board of Directors. The Board of Directors shall notify recipients of their selection for the award.

Nominations shall be in the form of a summary in 5 copies, providing biographical information and the accomplishments of the nominee which meet the Award requirements. Seconding letters are unnecessary.

The committee, appointed by President Cowan, is comprised of Robert Allen, Marvin Formo, Ed Hahn, Charles Hoerr, with Chairman Jay Harris.

The Award of Merit shall consist of a hand-engrossed personalized certificate.

## Society of Cosmetic Chemists To Meet May 8, 1969

The Society of Cosmetic Chemists will hold its semi-annual meeting on May 8, 1969 at the Americana Hotel, New York City. Scheduled for the one-day meeting are sessions on Cosmetic Technology, Bacteriology and Product Preservation Problems, and Long Range Planning.

The Long Range Planning session, to be held concurrently with one of the technical sessions, represents the Society's first intensive treatment of this timely subject. Topics to be discussed include:
