## SOCMA Announces Environmental Gold Medal Chemistry Award

The Synthetic Organic Chemical Manufacturers Association (SOCMA) has announced the establishment of a special Gold Medal award to recognize exceptional contributions in chemistry leading towards an improvement in the nation's environment. Announcement of the new program, believed to be the first such award in the nation, was made at a luncheon meeting in New York, November 11.

AOCS member L.W. Burnette of the GAF Corporation, Chairman of SOCMA's Research and Technical Programs Committee, pointed out that chemical industry can and must play a crucial role in cleaning up the environment.

"I believe our industry has not only done a remarkable job in the last few years in progress towards putting its own house in order, but has also made significant contributions in assisting other industries and municipalities in developing the technology necessary to limit air and water emissions. However we realize there is still much to be done and believe this new program will serve both to encourage and recognize contributions in this vital area," Burnette pointed out at a press briefing today.

"Many of the major improvements in pollution control equipment and procedures have come from research in chemistry and we believe expanded work in this area is the only way America will develop the necessary technology to meet the continually tightening environmental standards being established by state and federal governments. We hope this new program will lend support to those firms which are already working in this important area and will encourage others to not only increase their programs in environmental chemistry, but also to share the fruits of such research with all industry."

The 1972 SOCMA Medal will carry with it an honorarium of \$1000 and will be presented at an Association meeting in September 1972, at which time the recipient will have an opportunity to address leaders of the American chemical industry. Nomination papers for the 1972 Medal have already been distributed to independent research laboratories, universities, government agencies working in the environmental area, and business leaders throughout the country.
