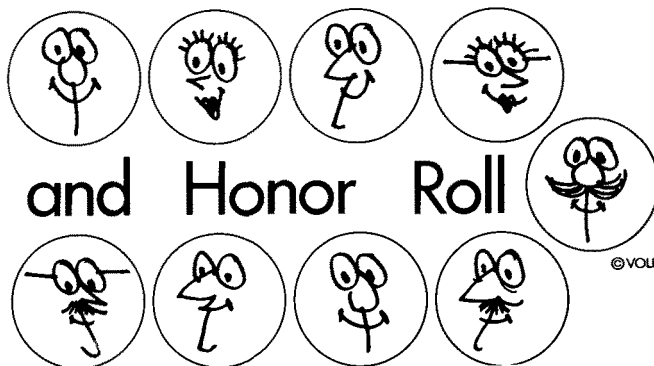




# President's Club and Honor Roll
