WHEN AND WHERE: The World Conference on Oilseed and Vegetable Oil Processing Technology will be held March 1-5, 1976, in Amsterdam, the Netherlands. The technical sessions and exhibits will be at the modern RAI Convention Centre.

PURPOSE: The Conference is planned as a technical discussion of the latest methods for processing oilseeds, meals and fats and oils to finished products. The idea is to bring together technical and operating personnel and expose them to principles and practice in the industry with speakers providing necessary background theory. Elements of the program are also designed to attract suppliers to and customers of the industry.

ORGANIZER: The American Oil Chemists' Society is the Conference organizer. Dr. T.H. Applewhite is conference chairperson, and Drs. C.J.M. Meershoek is local chairperson, acting for Vereniging van Nederlandse Fabrikanten van Eetbare Oliën en Vetten (VERNOF).

GENERAL FORMAT: The speakers have been selected because of their expertise in the subject areas of their presentations. Speakers will give papers to all participants in Plenary Sessions. The end of each day will be devoted to discussions in smaller groups.

SMALL GROUP DISCUSSIONS: After the plenary sessions each day, speakers and session chairpersons will be assigned to small group discussion sessions in meeting rooms at the RAI Centre. These sessions will give participants the opportunity to meet with the speakers to ask questions and to discuss more specific aspects of the presentations.

LANGUAGES: English and French are the official conference languages. Simultaneous translation will be provided in these languages. Should the demand for other languages be sufficiently strong, other languages may be added if the organizing committee feels it is advisable. See the registration form.

EXHIBITS: An added feature of the Conference is the exhibit of materials, processes, and suppliers of the industry. Space is available for over 70 exhibit booths. SOCIAL EVENTS: On Monday evening of the Conference, participants will be invited to a reception at one of Amsterdam's famous museums. On Wednesday, participants will be

guests for refreshments and a boat ride through Amsterdam Harbor to Zaanse Schans, site of the oldest operating linseed oil mill. The highlight of Conference social events will be a Dutch evening festival on Thursday. Social events, except for the optional Dutch evening, are included in the registration fee.

SPOUSES PROGRAM: Spouses accompanying participants to Amsterdam may register for a special program. Tentative plans include a canal tour and trip to a diamond cutters on Monday. An all-day tour, probably to the Hague, a Delft factory, and a flower auction, is being planned for Tuesday. A half-days activities will be planned for Thursday, possibly a visit to a cheese factory and to a shopping area. In addition, spouses will be invited to the regular conference social events described above.

ACCOMMODATIONS: Blocks of rooms are held at the Alpha and Crest Hotels, both only a short walk to the RAI Centre. Reservations may be made on the conference registration form. Tariffs are as follows and include all taxes, service, and breakfast:

Tariffs are quoted in Dutch guilders. A limited number of rooms at these hotels are available. Additional, but more expensive, accommodations will be secured by the organizing committee if necessary. *To ensure housing at the Conference hotels, please register early.*

SPECIAL TRAVEL FROM THE UNITED STATES: AOCS has chartered a Pan American plane to leave Chicago on February 27 and to return from Amsterdam on March 8. In addition, affinity group seats have been reserved on flights from Chicago and New York, leaving on February 27 and returning on March 12. Because of governmental regulations and terms of the contract with Pan American, it is essential that reservations for the charter or group flights be made early. 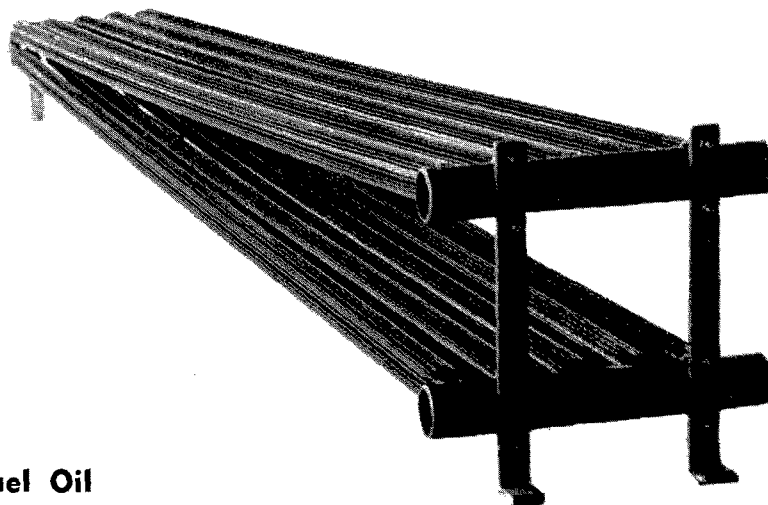

The form must be completed in its entirety and set with payment to VERNOF/AOCS, Raamweg 44, The Hague, The Netherlands. Housing reservations will be made by the organizing committee on receipt of the form. Registration will be confirmed by the committee. DEADLINES: Registration: You are urged to register early. See the reverse side of the registration form for late cancellation penalties. **Housing:** The Conference must release non-used hotel rooms 30-60 days prior to the conference. While it may be possible to secure rooms in the conference hotels after the cutoff date, it will be advisable to register prior to December 1, 1975 to ensure the most convenient housing accommodations. **Travel:** The airlines require that a decision be made by December 1, 1975, whether it is necessary to cancel the charter flight.
