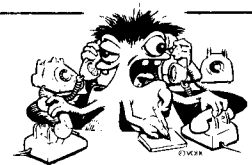

The Food and Drug Administration has extended until Oct. 31, 1978, the closing dates for color additives D&C Red No. 6, D&C Red No. 7, and D&C Red No. 30, pending development and evaluation of analytical methods for the colors. The closing date for caramel has been postponed until July 31, 1978, while a subchronic study is completed. Closing date for lead acetate is set as Dec. 31, 1978, pending a short term penetration study. The FDA also set July 31, 1981, for 25 color additives for food, drug, and cosmetic use. Details: *Federal Register*, Friday, April 7, 1978, pp. 14642-14643. ●

Combe Inc. has filed a petition for permanent listing of bismuth citrate as a color additive for hair coloring cosmetics. A previous petition submitted in 1973 was denied in 1977 when FDA said final reports of short term studies had not been submitted. FDA says the reports have now been submitted and the petition refiled. Details: *Federal Register*, Friday, April 7, 1978, p. 14737. ●

An FDA administrative law judge has ruled that FD&C Red No. 2 has not been shown to be safe and the petition for permanent listing should be denied. An appeal to the courts is expected. ●

Charles Downer & Co. Ltd. of Toronto, Canada, has been named exclusive representative in the United States and Canada by Meccaniche Moderne of Italy for sales of soap processing equipment . . . International Flavors & Fragrances Inc. has announced the start of construction on a substantial new IFF fragrance compounding factory in Drogheda, Republic of Ireland . . . PVO International Inc. is marketing a new emollient oil, Neobee 27, with a higher molecular weight to improve stability and to lessen skin irritation, combined with a low melting point, PVO's Chemical Specialties Division says. ●
