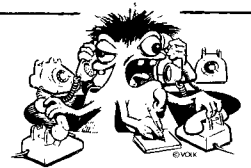

Committee agrees to continue new section

JAOCs' new Soaps, Detergents, and Cosmetics section should be continued, an advisory committee agreed during the annual AOCS meeting in St. Louis.

The committee recommended that an assistant editor be named to direct the section and also that the advisory committee become permanent. New associate editors also may be named to help review technical papers.

The new section was started earlier this year in the Journal after the World Conference on Soaps and Detergents in Montreux. The committee agreed the section can fill a need for basic technical papers as well as other information about the industries around the world.

The committee approved suggestions to provide more timely abstracts from meetings, as well as from publications, and efforts to provide regular contributions from outside the United States.

European detergent, U.S. cosmetic chemicals markets studied

European surfactant markets should grow at a 2.5% annual rate through 1985, with zeolites showing the major growth among builder ingredients, according to a market study by Colin A. Houston & Associates.

Houston said its report shows that energy and environmental concerns will be major factors in the market, with STPP losing a large part of its market share because of efforts to replace phosphate in detergents. Anionics and soap, with a 77% market share in 1976, should have about 73% by 1985, the firm said, with nonionics' market share rising from 18% to 20%.

Houston concludes that products in personal care group should grow at almost 7% annually, offering good business possibilities. Heavy duty liquids, with good growth in the United States, show less potential in Europe because of
