World Conference

Tentative schedule

A full program of technical, business and social sessions has been developed for the 1980 ISF/AOCS World Congress to be held April 27-May 1 at the New York Hilton in New York City.

While specific schedules remain to be developed, General Chairman and ISF President Peter Kalustian has outlined a tentative program that would begin at 12:30 p.m. Sunday, April 27, with an optional tour for ISF members, and conclude with optional cultural and plant tours on Friday, May 2.

The tentative schedule calls for the International Society for Fat Research and the American Oil Chemists' Society to hold their plenary business sessions late Sunday afternoon, following a trip to the Rutgers Food Science Department at New Brunswick, NJ, by European meeting registrants. An informal mixer reception will be held Sunday evening for all participants.

Monday will begin with a full breakfast plenary session with a distinguished invited speaker, followed by presentation of the AOCS Award in Lipid Chemistry and the acceptance lecture. Technical sessions will be held the remainder of the morning and afternoon. An optional theater party is being considered for Monday evening.

On Tuesday, a continental breakfast will be held for foreign registrants and persons attending their first AOCS national meeting, followed by a plenary session for presentation of the ISF's Kaufmann Award and the acceptance lecture. Technical sessions will be held the remainder of the day, with tentative plans for an optional sightseeing boat trip Tuesday evening.

On Wednesday, the AOCS Inaugural and Awards buffet breakfast will be held to include presentation of the AOCS Award of Merit, Honored Students Awards, Smalley Awards, and Bond Award, as well as the inauguration of new officers and address by the incoming president. Technical sessions will be held throughout the day, with the traditional banquet on Wednesday evening.

Thursday will be devoted solely to technical sessions. Friday's optional postmeeting tours will include an all-day visit to restorations in New York Hudson River Valley area of Sleepy Hollow and environs. A morning plant tour of the Nabisco facilities in Fairlawn and afternoon tour of the Hoffmann La Roche plant in Clifton are tentatively also planned for Friday.

Between 1,000 and 1,500 persons are expected to participate in the meeting, which will include an industrial exposition that will be open Sunday through Wednesday.
