## from Washington



The USDA estimates that U.S. farmers will harvest more acres of soybeans this fall than of corn, the first time that has happened. Soybeans passed wheat in total harvested acreage a year ago as well as now, if the USDA estimate proves correct. The estimate, made in mid-July, was that farmers would harvest 70.6 million acres of soybeans compared to 69.5 million to 70 million acres of corn.

The Work Group on Risk Assessment of the Interagency Regulatory Liaison Group (IRLG) has published a report on the "Scientific Bases for Identification of Potential Carcinogens and Estimation of Risks," outlining the current scientific concepts and methods used to identify possible chemical carcinogens. The EPA is calling for information in its health effects assessment of the chlorinated hydrocarbons trichloroethylene, methyl chloroform, methylene chloride and freon-113. The National Cancer Institute has concluded that buty-lated hydroxytoluene (BHT) is not carcinogenic for F344 rats or B6C3F1 mice. BHT was tested for safety in its applications as food additive, preservative and stabilizer in pesticides, lubricants, lipsticks and other products. The Agricultural Marketing Service has made a final ruling revising fees for cotton classing, standards and inspection sampling, and for certification of cottonseed and related services. The revision reflects rising costs since the adjustment of feed on July 1, 1976 and omits certain obsolete processing tests. The EPA has issued a reminder that written comments on a specific chemical substance should be submitted no later than 30 days before the end of the stated review period. The International Trade Commission will investigate casein's impact on the domestic dairy industry in compliance with a House Ways and Means Committee resolution. The United States Department of Energy has made final "Standby Conservation Plan No. 2, Emergency Building Temperature Restrictions" to place temporary limits on temperature settings in commercial, industrial and other nonresidential buildings during times of emergency energy conservation. The restrictions include temperature of 65 F for heating, 78 F for air conditioning and 105 F for hot water used in personal hygiene. For information, contact Henry G. The EPA has begun implementing the regulation which requires the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA) administrator to provide the secretary of the USDA with guidelines stating which information is necessary to support the registration of a pesticide. The Commodity Credit Corporation has issued the final ruling for determining adjustment and purchase rates for peanuts different from the national average, \$420 per ton. Pesticides containing dibromochloropropane (DBCP) may be suspended from use by the EPA because of possible "imminent hazard" to humans. DBCP-containing pesticides are used on various commercial crops, including cotton and soybean. The EPA may suspend any pesticide on an interim basis, until further information is available. ## **Executive Committee holds mid-year meeting**

Increased financial support for AOCS honored students, use of Continuing Education Units, and society financial investments were considered by the AOCS Executive Committee during its mid-year meeting in Champaign.

The Committee approved a proposal to increase financial aid to AOCS Honored Students attending the annual meeting. In the past, such students received airfare plus a flat \$75 to help pay expenses. Under the new plan, the students will receive airfare, plus \$15 per day meal expenses, plus hotel accommodations arranged through the headquarters office, not to exceed \$35 a day.

The committee heard a report from Education Committee Chairman E.G. Perkins suggesting AOCS join the Council on Continuing Education Units and award such credit to members participating in appropriate programs. The Executive Committee asked Perkins to continue his investigation of the topic and to report later. While some certifiable professions require such credits, most AOCS members at present do not, the committee felt. Using such credits, however, might attract more participation by professionals who do benefit by receiving the CEU credits.

In a structural change, the Executive Committee approved a proposal from AOCS Treasurer Tom Smouse that the finance committee's present investments subcommittee be replaced by a separate, full investment committee composed of the Society President, Treasurer and three other Governing Board members or alternates.

Smouse noted that investment is basically a different concern than budgeting, which is the finance committee's area. The new committee will report directly to the Governing Board. The Executive Committee also approved Smouse's proposal that finance committee members be appointed for one-year renewable terms, instead of the present three-year appointments.

In other actions, the Executive Committee:

- Received a final report on the World Conference on Vegetable Food Proteins from local chairman Kees Meershoek and voted to express official "heart-felt thanks" to Dr. and Mrs. Meershoek for their efforts.
- Approved a budget for 1980 showing total income of \$747,200 and expenses of \$714,000. The budget shows an increase of 13% in income from the 1979 budget and an increase of expenses slightly more than 2% from the 1979 budget. Most of the increase represents increased dues income, including that portion of dues allocated to subscriptions, and subscription income.
- Discussed holding a world conference on fatty chemicals during 1983, after hearing a report from AOCS President N.O.V. Sonntag on the industrial fatty acids short course held this past June.
- Asked Executive Director James Lyon to provide estimates on the cost of staff pension plant alternatives.
- Urged the proceedings of a 1980 soaps and detergents short course be published as a unit in JAOCS.
- Received a letter of ISF Executive Secretary Reinhard Marcuse asking for AOCS participation in nomination of candidates for ISF's Kaufmann Memorial Lecture Award.
