AOCS World Conference on

Oilseed and Edible Oil Processing

Organizers for the World Conference on Oilseeds and Edible Oil Processing have announced the plenary program for the meeting to be held Oct. 3-8, 1982, in the Congress Centre of The Hague, The Netherlands.

The program has been designed to provide a thorough study of how to process oilseeds and edible oils into finished products, covering state-of-the-art technology with emphasis on anticipated developments through the end of the century. There will be a comprehensive review of unit processes with specific attention to energy conservation, economic use of byproducts and potential for automation.

More than half the technical program speakers are from outside North America, indicating the international scope of the meeting. Afternoon discussion groups will provide registrants with the opportunity to question plenary speakers and to comment upon plenary talks. Program chairman Norm Witte is evaluating proposals for contributed papers. Proposals for such papers must reach Witte by June 1, 1982, to be considered. His address is N.H. The accompanying exposition by suppliers to the fats and oils industry will be open 2 to 6 p.m. on Sunday, Oct. 3, and be open from 10 a.m. to 6 p.m. on Monday, Oct. 4, Tuesday, Oct. 5 and Thursday, Oct. 7. The exhibits will not be open Wednesday, Oct. 6, as the plenary session will adjourn about lunch time for an all-conference tour to Rotterdam.

Organizers have scheduled social events to increase opportunity for informal discussion between participants. There will be a reception Sunday in the exhibit area, another reception Monday evening sponsored by local governmental authorities at a local cultural center and the Wednesday trip to Rotterdam. Participation in these events is included in the registration fee for the conference. There is an additional optional social event, a Dutch tropical evening, that will be held in nearby Leiden. The party will be similar to the Dutch evenings of previous AOCS World Conferences in Amsterdam. Tickets may be ordered on the registration form.

Six hotels have rooms at special rates for the conference, but reservations must be made by Sept. 1 to ensure rooms in these hotels at the rates quoted. Transportation will be provided between the hotels and the Congress Centre. The registration form contains specific information on room rates.

KLM Royal Dutch Airlines is official air carrier for the conference. For North American registrants only, Travelink Tours International in Rosemont, Illinois, has reserved space on trans-Atlantic flights at the lowest available fares, up to 40% below the regular coach fare.

While technical program registrants are meeting in the Congress Centre, their spouses will be able to participate in a series of tours that will include attractions in The Hague and the surrounding countryside. The Netherlands and the United States are marking 200 years of diplomatic relations and special events are scheduled in both nations throughout the year. The oilseed and edible oil conference is one of the official events of the observance.

The meeting registration desk at the Congress Centre in The Hague will open at 1 p.m. Sunday, Oct. 3, and at 8 a.m. on each of the following days of the conference.

Sunflower market appraised

Cautiously optimistic about what lies ahead for sunflower crushers, Cargill Sunflower Merchandising Manager Herbert L. Steed says he sees "at least a better year ahead...but probably not a great year."

Speaking in March before the 31st Oilseed Processing Clinic in New Orleans, Steed said that U.S. sunflower crushing facilities, which shut down in early 1982 because of negative crushing margins, should reopen this fall after the 1982 harvest.

"Our basic problem is a shortage of seed," Steed reports. "To a great extent, strong export demand for seed from the countries that will pay a premium pushes the price of sunflower oil to a price that the American consumer refuses to pay," Steed explains. The high price of sun oil relative to competing oils reduces demand for sun oil, which in turn "squeezes" the margin for the U.S. processor, making it unprofitable to crush the seed.

Steed expects this situation to improve, though, because producers are beginning to realize that current sun seed prices offer a better return than alternative crops. A larger crop should mean that sunflower seed will be more pricecompetitive with other oilseeds, and hence more profitable for the processor to crush and more acceptable to cost-conscious consumers.

But the condition of the industry will worsen before it improves, Steed predicts. Larry Kleingartner, executive director of the National Sunflower Association, has reported that Argentina sun oil has been selling for considerably less than the United States', detracting from the demand for U.S. sun oil. Steed foresees this situation growing more intense as cheap supplies of sun oil out of Argentina move to the export market this spring and summer. "We're facing a very grim economic situation," laments Steed.

Penn State to host triennial meeting

The Triennial Meeting of the American Institute of Nutrition, the American Society for Clinical Nutrition, and the Canadian Society for Nutritional Sciences will be held July 22-24, 1982, at Pennsylvania State University.

Analytical short course planned

An AOCS Short Course on Analysis of Lipids and Lipoproteins is scheduled to be held Nov. 7-10, 1982, at the Chateau Louise in Dundee, Illinois. Dundee is a suburb of Chicago.

Subjects will include separation of lipids from animal and plant tissue, derivatives for chromatography and mass spectrometry; separation of neutral lipids; separation of phospholipids; separation of complex lipids; prostaglandins; structure determination; analytical techniques; measurement and use of volatile compounds in assessing fat and oil quality; lipoproteins; analytical and structural methodology as well as others.

The course is a follow-up to AOCS' 1970s short courses on lipid and lipoprotein analysis.

Symposium on lipids in cancer

"Lipids in Cancer" is the topic of a symposium to be held in association with the 12th International Congress of Biochemistry in Australia this summer.

The program will consist of an overview of the subject area, four discussion sessions, and a debate:

Overview: Cancer — the questions that must be answered: Session 1, That carcinogenesis requires a specific lipid environment; Session 2, That lipid metabolism regulates cell division; Session 3, That cellular membranes do as their lipids tell them; Session 4, That fat in the food dictates life in the tumor; and Debate, That cancer is a membrane disease.

The symposium will be held aboard the train Indian-Pacific Express, leaving Sydney on August 12 and arriving in Perth for the opening of the Congress on August 15.

Oilseed processing clinic held

The 31st Oilseed Processing Clinic drew 150 participants to New Orleans March 15-16, 1982. The meeting, sponsored by the Mississippi Valley Oilseed Processors Association and the USDA Southern Regional Research Center, featured 13 presentations and a poster session on various topics, including processing technology, government regulation, export markets and economics.

Five AOCS members were among the speakers. Robert J. Hron presented an "Overview of Alternate Renewable Resource Solvents for Vegetable Oil Extraction," and Edmund Lusas discussed "Producing Edible Oil and Protein from Oilseeds by Aqueous Processing." Former AOCS President George C. Cavanagh detailed "Some Applications of Near Infrared Reflectance Spectroscopy in the Oilseed Industry." Edith J. Conkerton focused on "Bioregulators and Their Effect on Seed Properties" in the poster session. "Research Developments in Applications of Supercritical Fluids" were reported by Timothy L. Mounts, who also presented a poster paper on supercritical CO₂ extraction of oil-bearing materials.

ISF meeting canceled

The scheduled meeting of the International Society for Fat Research for 1982 in Gdansk, Poland, has been canceled because of economic difficulties. Organizers in Poland had obtained approval of a conference budget from the Polish Academy of Sciences, but funds to accomplish objectives were not available. ISF officials are considering alternatives.
