Fatty acid speakers listed

Ten faculty members have been announced for the AOCS Short Course on Fatty Acids to be held Sept. 23-26, 1984, at Kings Island, Ohio.

The short course will cover raw materials, processing, end products and their uses, analytical chemistry, environmental concerns and new developments in fatty acids. Approximately two dozen presentations will be given during the meeting.

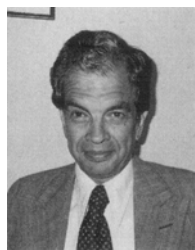

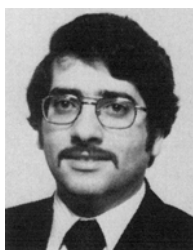
