# Double intramolecular hetero Diels-Alder reactions of $\alpha, \boldsymbol{\beta}$-unsaturated hydrazones as 1 -azadienes: a new route to 2,2'-bipyridines

Salicylaldehyde was converted into the $O$-propynyl- and $O$-butynyl $\alpha, \beta$-unsaturated aldehydes $\mathbf{4}$ and ketones $\mathbf{6}$, subsequent reaction of which with $N, N$-dimethylhydrazine and alkyne homocoupling gave the 1,3 -diyne bis(hydrazones) 8, substrates for a double intramolecular hetero Diels-Alder reaction. Similar substrates 11, 15a/15c and $\mathbf{1 5 b} / \mathbf{1 5 d}$ were prepared from 2-( $N$-benzoylamino)cinnamaldehyde, hex- 5 -ynol and hept- 6 -ynol respectively. Heating the 1,3 -diynyl bis( $\alpha, \beta$-unsaturated hydrazones) 8a, 8c, $\mathbf{1 1}$ and $\mathbf{1 5 a}$ resulted in double intramolecular Diels-Alder reaction to give, after aromatisation by loss of dimethylamine, 2,2'-bipyridines 21-24.

## Introduction

2, $2^{\prime}$ - Bipyridine was first synthesised by Fritz Blau in 1888 by distilling a salt of picolinic acid (pyridine-2-carboxylic acid). ${ }^{1}$ Its ability to form complexes with metal salts was recognised immediately, and in the intervening 110 years it has been extensively used as a chelating ligand in organometallic chemistry. ${ }^{2}$ In fact, $2,2^{\prime}$-bipyridine is one of the best known and most effective bidentate ligands for a range of metals, and with the recent emphasis on the use of metal catalysts in asymmetric synthesis, it is not surprising that chiral $2,2^{\prime}$-bipyridine ligands have found wide application. Thus, for example, chiral $2,2^{\prime}$ bipyridines have found use in the asymmetric addition of diethylzinc to aldehydes, ${ }^{3}$ asymmetric cyclopropanation reactions, ${ }^{4}$ and asymmetric allylic alkylation. ${ }^{5}$ However, the methods used to prepare functionalised bipyridines often rely on the modification of existing pyridine rings followed by transition-metal catalysed heteroaryl coupling reactions. In view of our work on the preparation of substituted pyridines using ring synthesis reactions, ${ }^{6}$ we became interested in developing a route to $2,2^{\prime}$-bipyridines in which both pyridine rings are constructed from an acyclic precursor in a single step. There is a previous example of this approach involving cobalt( I ) catalysed $[2+2+2]$-cycloadditions between hex- 5 -ynenitrile and 1,3 -diynes, ${ }^{7}$ and we now report full details of a different approach based on the double intramolecular hetero DielsAlder reaction of 1,3 -diynyl bis( $\alpha, \beta$-unsaturated hydrazones) (Scheme 1). ${ }^{8,9}$

The preparation of 6-membered ring heterocyclic compounds by the hetero Diels-Alder reaction is an established tactic in organic synthesis, ${ }^{10}$ and the use of both 1-aza- and 2-
aza-dienes as components in such reactions is well known. ${ }^{11}$ One useful route to pyridine derivatives employs $\alpha, \beta$-unsaturated hydrazones as 1-azadienes, and since the pioneering work of Ghosez, ${ }^{12}$ these dienes have found use in intermolecular Diels-Alder reactions to give pyridine derivatives, the reaction with quinones as dienophiles being particularly well investigated. ${ }^{13}$ Intramolecular Diels-Alder (IMDA) reactions of $\alpha, \beta$-unsaturated hydrazones with alkynes have also been reported, ${ }^{14}$ and this is an attractive route to annelated pyridines since the initial Diels-Alder adduct readily aromatises by loss of dimethylamine. ${ }^{15}$ Therefore, we decided to adapt this procedure to the direct synthesis of annelated $2,2^{\prime}$-bipyridines by the incorporation of an oxidative homocoupling step giving a 1,3-diyne as a bis(dienophile) capable of undergoing the desired double IMDA reaction (Scheme 1).

## Results and discussion

The substrates for the double IMDA reactions were prepared by a number of routes (Schemes 2-6). The first series of compounds was based on salicylaldehyde $\mathbf{1}$; thus, reaction of the aldehyde 1 with (formylmethylene)triphenylphosphorane gave $o$-hydroxycinnamaldehyde 2 in $83 \%$ yield on a small scale. Although this aldehyde 2 could be readily converted into the required propargyl (prop-2-ynyl) derivative 4a, its preparation proved irreproducible and low yielding on a larger scale. Therefore, the $\alpha, \beta$-unsaturated aldehyde $\mathbf{4 a}$ was prepared by carrying out the $O$-propargylation first, and reacting the aldehyde $\mathbf{3 a}$ with $\alpha, \alpha$-bis(trimethylsilyl)- $N$-tert-butylacetaldehyde imine in the presence of zinc bromide. ${ }^{16}$ This reagent proved superior to the Wittig reagent (formylmethylene)triphenylphosphorane. A similar sequence of reactions was used to prepare the $O$-butynyl derivative 4b (Scheme 2). The corresponding $\alpha, \beta$-unsaturated methyl ketones 6 were also prepared as shown in Scheme 3.

The $\alpha, \beta$-unsaturated aldehydes $\mathbf{4}$ and methyl ketones $\mathbf{6}$ were readily converted into the corresponding $N, N$-dimethylhydrazones 7 and hence to the 'dimeric' 1,3-diynes $\mathbf{8}$ by GlaserEglinton coupling with copper(II) acetate ${ }^{17}$ as shown on Scheme 4.

The IMDA substrate 11 was prepared from the known hydrazone $9,{ }^{18}$ obtained from quinoline and benzoyl chloride
 cinnamaldehyde followed by hydrazone formation. The sequent $N$-propargylation and oxidative homocoupling of the alkyne both proceeded in good yield as shown in Scheme 5.

The final set of substrates were obtained from hex-5-ynol 12a or hept-6-ynol 12b. Although the former alkynol is commercially available, the latter was obtained by base catalysed isomerisation of hept-3-ynol. ${ }^{19}$ Homocoupling reaction of the alkynols $\mathbf{1 2}$ gave the corresponding 1,3-diynes $\mathbf{1 3}$, readily oxidised to the dialdehydes 14 using 1 -hydroxy-3-oxo-1,3-dihydro-1,2-benziodoxole 1-oxide ( 2 -iodylbenzoic acid, IBX) in DMSO. ${ }^{20}$ The dialdehydes 14 were converted directly into the hydrazones 15 a and $\mathbf{1 5 b}$ of the homologous $\alpha, \beta$-unsaturated aldehydes by reaction with the $N, N$-dimethylhydrazone of diethyl formylmethylphosphonate in a Wadsworth-Emmons reaction. ${ }^{15}$ Alternatively the $\alpha, \beta$-unsaturated ketones 16 were prepared by Wittig reaction with aldehydes 14, followed by reaction with $N, N$-dimethylhydrazine to give the hydrazones $\mathbf{1 5 c}$ and 15d as shown in Scheme 6.

Although the main aim was to investigate the double IMDA reaction of the 1,3-diynes (see below), the IMDA reactions of the mono-alkynes 7 were also briefly investigated. The IMDA reaction of the hydrazone 7 a occurred upon heating in xylene in a sealed tube and gave the chromeno[3,4-c]pyridine 17 in $59 \%$

yield as reported by Dolle and co-workers in their original paper, ${ }^{15}$ although a minor byproduct was also isolated. This was identified as the benzopyran 18, and presumably results from a [3,3]-sigmatropic rearrangement followed by [1,5]-hydrogen shift and cyclisation, a known reaction of aryl propargyl ethers. ${ }^{21}$ Attempts to catalyse the IMDA reaction using LiNTf $_{2}$, a system employed successfully by Ghosez and coworkers with $\alpha, \beta$-unsaturated hydrazone based azadienes, ${ }^{12 c}$ proved unsuccessful.
The $\alpha, \beta$-unsaturated ketone hydrazone 7c also underwent IMDA reaction to give the pyridine 19 in modest yield. $\alpha, \beta$ Unsaturated hydrazones with a substituent at C-2 are known to be poorer 1-azadienes, since the substituent (methyl in this case) forces the dimethylamino group out of the diene plane thereby preventing the delocalisation of the nitrogen lone pair which enhances the diene reactivity. ${ }^{12 c}$ The two butynyl derivatives $\mathbf{7 b}$ and $\mathbf{7 d}$, however, failed to give any of the benzoxepinopyridines 20 on heating in xylene (Scheme 7). The formation of 7-membered rings in IMDA reactions is generally less favourable than the corresponding reactions which form 6 - (or 5-) membered rings. ${ }^{22}$

The key double IMDA reactions were next investigated. Heating the 1,3-diyne bis(hydrazone) 8a in xylene gave the desired annelated 2,2'-bipyridine 21 as the only isolable product. (ca. $80 \%$ yield), although considerable losses occurred during purification. The ketone derived substrate $8 \mathbf{c}$ was less satisfactory in the double IMDA reaction, and gave a poor yield of the unsymmetrical 2, $2^{\prime}$-bipyridine 22 in which one of the benzopyran rings has undergone oxidation at the activated $\mathrm{CH}_{2}$ position to give the observed lactone (Scheme 8). As with

the mono-alkynes $\mathbf{7 b}$ and $\mathbf{7 d}$, the diynes $\mathbf{8 b}$ and $\mathbf{8 d}$ failed to undergo IMDA reaction. The $N$-benzoyl compound 11, a nitrogen containing analogue of 8a, underwent smooth double IMDA reaction on heating in xylene to give, after loss of dimethylamine, the $N$-benzoylated dihydro 4,4'-bi(benzo[c][2,7]naphthyridine) 23 in $68 \%$ yield. Compound $\mathbf{2 3}$ could be deprotected by reaction with DIBAL-H, and the resulting dihydro compound dehydrogenated with palladium-on-carbon to give the aromatic bi(benzonaphthyridine) 25 (Scheme 9).

Finally, in the series of substrates $\mathbf{1 5}$, in which the azadiene fragment is connected to the alkyne dienophile by a simple alkyl chain, compound $15 a$ readily underwent the desired double IMDA reaction in boiling xylene to give the $1,1^{\prime}$-bi(cyclopenta [c]pyridine) 24 in good yield. Unfortunately no bipyridine products were isolated from the hydrazones $\mathbf{1 5 b}, \mathbf{1 5}$ c, or $\mathbf{1 5 d}$.

Although the IMDA reactions of 1,3-diyne bis(hydrazones) successfully demonstrated our aim of achieving a $2,2^{\prime}$ bipyridine synthesis in which both heterocyclic rings are formed in a single step from an acyclic precursor, the results are somewhat mixed. For a successful double IMDA reaction to occur the substrates need to be carefully designed, and this is clearly a major consideration if chiral $2,2^{\prime}$-bipyridines are to be made by this route

## Experimental

## General

Commercially available reagents and solvents were used throughout without further purification unless otherwise stated. Light petroleum refers to the fraction that boils between 40 and $60^{\circ} \mathrm{C}$ and was distilled from calcium chloride through a 36 cm Vigreux column before use. Ether, which refers to diethyl ether, and THF were distilled from sodium-benzophenone ketyl under nitrogen prior to use. Dichloromethane was purified and dried by distillation from phosphorus pentaoxide under nitrogen

Analytical thin layer chromatography was carried out using aluminium or glass backed plates coated with Merck Kieselgel $60 \mathrm{GF}_{254}$. Developed plates were visualised under ultraviolet light ( 254 nm ) and/or potassium permanganate or ninhydrin dip. Flash chromatography was carried out using Merck Kieselgel 60 H silica. Fully characterised compounds were chromatographically homogeneous.

IR Spectra were recorded on Nicolet FT-205, Nicolet Magna 550 or Perkin Elmer Paragon 1000 FT-IR spectrometers with internal calibration. Spectra were recorded as thin films on sodium chloride plates, in solution or potassium bromide discs. NMR spectra were recorded on Bruker AC-250, AM-300 or Advance DRX-400 spectrometers at the frequencies stated. Chemical shifts are recorded in ppm and $J$ values in Hz . Multiplets less than 0.2 ppm in width were recorded from the centre, those greater were reported as a range. Chemical shift values are referenced against residual chloroform at 7.27 ppm for $\mathrm{CDCl}_{3}$, and are accurate to $\pm 0.01 \mathrm{ppm}\left(\delta_{\mathrm{H}}\right)$ and $\pm 0.10 \mathrm{ppm}$ $\left(\delta_{\mathrm{C}}\right)$. High resolution mass spectra (CI and EI ) were obtained either on Kratos MS80 or Profile HV3 spectrometers or at the EPSRC National Mass Spectrometry Service at the University of Wales, Swansea.

## Reagents and starting materials

$N$-tert-Butylacetaldehyde imine was prepared by the condensation of acetaldehyde with tert-butylamine in $54 \%$ yield. ${ }^{23}$ Diethyl formylmethylphosphonate was prepared by hydrolysis of the commercially available diethyl acetal (diethyl 2,2diethoxyethylphosphonate) in $62 \%$ yield. ${ }^{24}$ Hept-6-ynol 12b was prepared by the base catalyzed isomerization of hept-3 ynol ( $52 \%$ yield). ${ }^{19}$ IBX (1-hydroxy-3-oxo-1,3-dihydro-1,2benziodoxole 1-oxide) (CAUTION! IBX has been reported to explode when heated above $200^{\circ} \mathrm{C}$ and when subjected to shock) was prepared from 2-iodobenzoic acid, according to the method of Dess and Martin ${ }^{25}$ in $71 \%$ yield.

## $\alpha, \alpha$-Bis(trimethylsilyl)-tert-butylacetaldehyde imine

Diisopropylamine ( $14 \mathrm{ml}, 100 \mathrm{mmol}$ ) was stirred in THF $(50 \mathrm{ml})$ at $-20^{\circ} \mathrm{C}$, $n$-butyllithium ( 1.6 M in hexane; 63 ml , 100 mmol ) was added slowly and the temperature reduced to $-60^{\circ} \mathrm{C}$. tert-Butylacetaldehyde imine ${ }^{23}(5.0 \mathrm{~g}, 50 \mathrm{mmol})$ was added dropwise, the solution was stored at -78 to $-60^{\circ} \mathrm{C}$ for 18 h and then chlorotrimethylsilane ( $6.5 \mathrm{ml}, 50 \mathrm{mmol}$ ) was added dropwise. After 5 h another portion of chlorotrimethylsilane ( $6.5 \mathrm{ml}, 50 \mathrm{mmol}$ ) was added, the solution was stirred for 45 min and then allowed to warm to room temperature. The suspension was filtered through Celite and the solvent removed
in vacuo. The residue was purified by distillation under reduced pressure and the title compound was obtained as a yellow oil ( $5.0 \mathrm{~g}, 41 \%$ ); bp $104-107^{\circ} \mathrm{C}$ at 20 mmHg (lit., ${ }^{16} 93-94^{\circ} \mathrm{C}$ at 12 $\mathrm{mmHg}) ; v_{\text {max }}($ film $) / \mathrm{cm}^{-1} 2964,2900$, 2868, 1637, 1252, 840; $\delta_{\mathrm{H}}\left(300 \mathrm{MHz} ; \mathrm{CDCl}_{3}\right) 7.49(1 \mathrm{H}, \mathrm{d}, J 10.1, \mathrm{CH}=\mathrm{N}), 1.58(1 \mathrm{H}, \mathrm{d}$, $J$ 10.1, (TMS) $\left.{ }_{2} \mathrm{CH}\right), 1.14\left(9 \mathrm{H}, \mathrm{s}, \mathrm{CMe}_{3}\right), 0.04\left(18 \mathrm{H}, \mathrm{s}, \mathrm{SiMe}_{3}\right)$; $\delta_{\mathrm{C}}\left(75 \mathrm{MHz} ; \mathrm{CDCl}_{3}\right) 157.9(\mathrm{CH}), 56.4(\mathrm{C}), 31.6(\mathrm{CH}), 30.0$ (Me), $-0.2(\mathrm{Me})$.

## Diethyl formylmethylphosphonate $\boldsymbol{N}, \mathbf{N}$-dimethylhydrazone

Diethyl formylmethylphosphonate ${ }^{24}(2.1 \mathrm{~g}, 12 \mathrm{mmol})$ was stirred in dichloromethane $(26 \mathrm{ml})$ at $0^{\circ} \mathrm{C}$, and $N, N$-dimethylhydrazine ( $3.54 \mathrm{ml}, 46.6 \mathrm{mmol}$ ) was added dropwise. After 3 h , the mixture was filtered and the solvent removed in vacuo to give the title compound as a light yellow oil ( $2.4 \mathrm{~g}, 92 \%$ ) (lit., ${ }^{15}$ bp $122-124^{\circ} \mathrm{C}$ at 10 mmHg ) (Found: $\mathrm{M}^{+}$, 222.1136. $\mathrm{C}_{8} \mathrm{H}_{19}-$ $\mathrm{N}_{2} \mathrm{O}_{3} \mathrm{P}$ requires 222.1133); $v_{\text {max }}($ film $) / \mathrm{cm}^{-1} 2938,2907,2805$, $2827,1256,1026 ; \delta_{\mathrm{H}}\left(300 \mathrm{MHz} ; \mathrm{CDCl}_{3}\right) 6.44(1 \mathrm{H}, \mathrm{dt}, J 10.3$, $5.8, \mathrm{CH}=\mathrm{N}), 4.07\left(4 \mathrm{H}, \mathrm{m}, \mathrm{OCH}_{2}\right), 2.78(2 \mathrm{H}, \mathrm{dd}, J 21.4$, $5.8, \mathrm{PCH}_{2}$ ), $2.74\left(6 \mathrm{H}, \mathrm{s}, \mathrm{NMe}_{2}\right), 1.28(6 \mathrm{H}, \mathrm{td}, J 7.0,0.3, \mathrm{Me})$; $\delta_{\mathrm{C}}\left(75 \mathrm{MHz} ; \mathrm{CDCl}_{3}\right) 126.2(\mathrm{CH}), 62.0\left(\mathrm{CH}_{2}\right), 43.0(\mathrm{Me}), 31.4$ $\left(\mathrm{CH}_{2}\right), 16.4(\mathrm{Me}) ; \delta_{\mathrm{P}}\left(121 \mathrm{MHz} ; \mathrm{CDCl}_{3}\right) 26.6 ; \mathrm{m} / \mathrm{z}(\mathrm{EI}) 222\left(\mathrm{M}^{+}\right.$, $12 \%), 180$ (4), 152 (51), 125 (68), 108 (22), 97 (37), 85 (100).

## ( E)-3-(2-Prop-2-ynyloxyphenyl)propenal 4a

Method 1. To a stirred suspension of (formylmethylene)triphenylphosphorane ( $486 \mathrm{mg}, 1.6 \mathrm{mmol}$ ) in dry tetrahydrofuran was added a solution of salicylaldehyde $(100 \mathrm{mg}$, 0.8 mmol ) in tetrahydrofuran ( 1 ml ). The reaction mixture was stirred at room temperature for 3 h . The solvent was evaporated and the crude residue was filtered through a pad of silica gel (light petroleum-ethyl acetate $2: 1$ ) to remove base line impurities. Concentration of the filtrate yielded ( $E$ )-3-(2hydroxyphenyl)propenal 2 as a yellow solid ( $100 \mathrm{mg}, 83 \%$ ), $\mathrm{mp} 131-132{ }^{\circ} \mathrm{C}$ (lit., ${ }^{16} \mathrm{mp} 122{ }^{\circ} \mathrm{C}$ ); $\delta_{\mathrm{H}}\left(250 \mathrm{MHz} ; \mathrm{CDCl}_{3}\right) 9.60$ ( $1 \mathrm{H}, \mathrm{d}, J 8.0, \mathrm{CHO}$ ), 7.91 ( $1 \mathrm{H}, \mathrm{d}, J 16.0$, $\mathrm{PhCH}=$ ), $7.57(1 \mathrm{H}$, td, $J 16.0,8.0$, $=\mathrm{CHCHO}), 6.93-6.86(4 \mathrm{H}, \mathrm{m}, \mathrm{ArH}) ; \delta_{\mathrm{C}}(62.5$ $\mathrm{MHz}, \mathrm{CDCl}_{3}$ ) 199.5 (CHO), 161.2 (C), 154.7 (CH), 136.4 (CH), $133.0(\mathrm{CH}), 131.8(\mathrm{CH}), 124.9(\mathrm{C}), 123.3(\mathrm{CH}), 119.6(\mathrm{CH})$. On a larger scale, this reaction was irreproducible, and gave yields of ca. $30 \%$.
A mixture of the above hydroxyaldehyde 2 ( 100 mg , 0.6 mmol ), propargyl chloride ( $50 \mu \mathrm{l}, 1.0 \mathrm{mmol}$ ) and potassium carbonate ( 80 mg ) in anhydrous ethanol ( 10 ml ) was heated to reflux for 18 h under an inert atmosphere. The mixture was filtered, evaporated in vacuo, diluted with dichloromethane, washed with sodium hydroxide solution ( $3 \times 50 \mathrm{ml}, 10 \%$ solution), and washed with water ( $3 \times 50 \mathrm{ml}$ ). The organic extracts were dried $\left(\mathrm{MgSO}_{4}\right)$ and concentrated in vacuo to leave a yellow oil which was chromatographed on silica gel (light petroleumethyl acetate $2: 1$ ) to give the title compound as a yellow semi-solid ( $113 \mathrm{mg}, 90 \%$ ), data given below.

Method 2. Propargyl chloride ( $3.6 \mathrm{ml}, 50 \mathrm{mmol}$ ) was added dropwise to a stirred solution of salicylaldehyde $(1.1 \mathrm{ml}$, 10 mmol ) and potassium carbonate ( $2.1 \mathrm{~g}, 15 \mathrm{mmol}$ ) in ethanol $(50 \mathrm{ml})$. The solution was heated at reflux for 20 h and then allowed to cool to room temperature and the solvent removed in vacuo. The residue was partitioned between sodium hydroxide solution ( $2 \mathrm{M} ; 70 \mathrm{ml}$ ) and ether ( 70 ml ), the organic phase was washed with further sodium hydroxide solution $(2 \mathrm{M} ; 2 \times 70 \mathrm{ml})$ and water $(2 \times 70 \mathrm{ml})$ and dried $\left(\mathrm{MgSO}_{4}\right)$. The mixture was filtered and concentrated in vacuo and purified by flash chromatography (elution with $2: 1$ light petroleum-ether) to give 2-prop-2-ynyloxybenzaldehyde 3a as a colourless solid ( $1.2 \mathrm{~g}, 76 \%$ ); mp $69{ }^{\circ} \mathrm{C}$ (from light petroleum) (lit., ${ }^{26} 68^{\circ} \mathrm{C}$ ); $\delta_{\mathrm{H}}\left(300 \mathrm{MHz} ; \mathrm{CDCl}_{3}\right) 10.5(1 \mathrm{H}, \mathrm{s}, \mathrm{CHO}), 7.86(1 \mathrm{H}, \mathrm{dd}, J 7.7$, 1.7, ArH), 7.57 ( 1 H , ddd, $J 8.6,7.3,1.7, \mathrm{ArH}$ ), 7.13-7.06 (2 H, $\mathrm{m}, \mathrm{ArH}), 4.83\left(2 \mathrm{H}, \mathrm{d}, J 2.4, \mathrm{OCH}_{2}\right), 2.57(1 \mathrm{H}, \mathrm{t}, J 2.4, \equiv \mathrm{CH})$.

Prop-2-ynyloxybenzaldehyde 3a ( $640 \mathrm{mg}, 4.0 \mathrm{mmol}$ ) and zinc bromide ( $900 \mathrm{mg}, 4.0 \mathrm{mmol}$ ) were stirred in THF ( 4 ml ) at room temperature. $\alpha, \alpha$-Bis(trimethylsilyl)-tert-butylacetaldehyde imine ( $1.1 \mathrm{~g}, 4.4 \mathrm{mmol}$ ) in THF ( 2 ml ) was added dropwise. After 3 h the reaction was quenched by addition of aqueous zinc chloride ( 800 mg in 8 ml of water) and ether ( 10 ml ) with stirring for 1 h . Salicylaldehyde ( $2.3 \mathrm{~g}, 19 \mathrm{mmol}$ ) was stirred in toluene ( 100 ml ), sodium ethoxide ( $21 \% \mathrm{w} / \mathrm{w}$ in ethanol, $1.1 \mathrm{~g}, 15 \mathrm{mmol}$ ) in ethanol was added dropwise and the suspension stirred for 1.5 h . But-3-yn-1-yl methanesulfonate ${ }^{27}(4.6 \mathrm{~g}, 31 \mathrm{mmol})$ was added slowly and the mixture heated to reflux for 7 days. The solution was cooled and partitioned between ether ( 300 ml ) and sodium hydroxide solution ( $2 \mathrm{M} ; 300 \mathrm{ml}$ ). A suspension of 4-(2-hydroxyphenyl)but-3-en-2-one 5 ( 800 mg , $4.9 \mathrm{mmol})$ and potassium carbonate $(2.0 \mathrm{~g})$ in ethanol $(30 \mathrm{ml})$ was stirred at $45^{\circ} \mathrm{C}$. Propargyl chloride $(1.8 \mathrm{ml}, 25 \mathrm{mmol})$ was added. A solution of copper(II) acetate monohydrate ( $8.0 \mathrm{~g}, 40 \mathrm{mmol}$ ) in ether $(400 \mathrm{ml})$, methanol $(100 \mathrm{ml})$ and pyridine $(120 \mathrm{ml})$ was stirred at reflux. ## 2,2'-Dimethyl-4,4'-bi(5H-chromeno[3,4-c]pyridin)-5-one 22

A solution of the bis( $N, N$-dimethylhydrazone) 8 c ( 120 mg , 0.25 mmol ) in mesitylene ( 10 ml ) was heated at reflux for 48 h . The solvent was removed in vacuo and the crude residue

## 6,6'-Dibenzoyl-5,5',6,6'-tetrahydro-4,4'-bi(benzo[c][2,7]naphthyridine) 23

A solution of the $\operatorname{bis}(N, N$-dimethylhydrazone) 11 ( 100 mg , 0.1 mmol ) in xylene ( 2 ml ) was heated at reflux for 2 h . After cooling, the solvent was removed in vacuo and the crude residue was chromatographed on silica gel (ether) to yield the desired Diels-Alder adduct as a pale brown solid ( $58 \mathrm{mg}, 68 \%$ ), mp 163-165 ${ }^{\circ} \mathrm{C}$ (Found: $\mathrm{MH}^{+}$, 571.2133. $\mathrm{C}_{38} \mathrm{H}_{26} \mathrm{~N}_{4} \mathrm{O}_{2}+\mathrm{H}$ requires $571.2134)$; $v_{\text {max }}(\mathrm{KBr}) / \mathrm{cm}^{-1} 3432,1653 ; \delta_{\mathrm{H}}\left(400 \mathrm{MHz} ; \mathrm{CDCl}_{3}\right)$ $8.66(1 \mathrm{H}, \mathrm{d}, J 5.0, \mathrm{ArH}), 7.85(1 \mathrm{H}, \mathrm{dd}, J 8.0,1.0, \mathrm{ArH}), 7.76$ ( $1 \mathrm{H}, \mathrm{d}, J 5.0, \mathrm{ArH}), 7.40-7.09(7 \mathrm{H}, \mathrm{m}, \mathrm{ArH}), 6.83(1 \mathrm{H}, \mathrm{d}$, $J 5.0, \mathrm{ArH}), 5.16\left(2 \mathrm{H}, \mathrm{s}, \mathrm{NCH}_{2}\right) ; \delta_{\mathrm{C}}\left(100 \mathrm{MHz} ; \mathrm{CDCl}_{3}\right) 169.8$ (C), 154.2 (C), 148.3 (CH), 139.8 (C), 138.2 (C), 135.3 (CH), $131.0(\mathrm{CH}), 130.3(\mathrm{CH}), 129.8(\mathrm{CH}), 129.5(\mathrm{CH}), 128.6(\mathrm{CH})$, $128.5(\mathrm{CH}), 128.4(\mathrm{CH}), 126.6(\mathrm{CH}), 126.4(\mathrm{CH}), 125.9(\mathrm{CH})$, $125.3(\mathrm{C}), 117.6(\mathrm{CH}), 44.9\left(\mathrm{CH}_{2}\right) ; m / z(\mathrm{CI}) 571\left(\mathrm{MH}^{+}, 100 \%\right)$.

## 6,6', $\mathbf{7 , 7}^{\prime}$-Tetrahydro-1,1'-bi(5H-cyclopenta[c]pyridine) $\mathbf{2 4}$

Hexadeca-2,14-diene-7,9-diyne-1,16-dial $\operatorname{bis}(N, N$-dimethylhydrazone) 15 a ( $48 \mathrm{mg}, 0.15 \mathrm{mmol}$ ) was heated to $145^{\circ} \mathrm{C}$ in xylene ( 3 ml ) for 9 h . The solvent was removed in vacuo and the residue purified by flash chromatography (elution with ether containing $3 \%$ triethylamine) to give the title compound as light yellow crystals ( $27 \mathrm{mg}, 76 \%$ ); mp $106-108^{\circ} \mathrm{C}$ (from ether) (Found: $\mathrm{M}^{+}$, 236.1303. $\mathrm{C}_{16} \mathrm{H}_{16} \mathrm{~N}_{2}$ requires 236.1313); $v_{\text {max }}\left(\mathrm{CHCl}_{3}\right) / \mathrm{cm}^{-1} 2962,1570,1433 ; \delta_{\mathrm{H}}\left(300 \mathrm{MHz} ; \mathrm{CDCl}_{3}\right) 8.42$ $(2 \mathrm{H}, \mathrm{d}, J 4.9, \mathrm{ArH}), 7.18(2 \mathrm{H}, \mathrm{d}, J 4.9, \mathrm{ArH}), 3.12(4 \mathrm{H}, \mathrm{t}, J 7.5$, $\left.\mathrm{ArCH}_{2}\right), 2.97\left(4 \mathrm{H}, \mathrm{t}, J 7.5, \mathrm{ArCH}_{2}\right), 2.07(4 \mathrm{H}$, quin, $J 7.5$, $\left.\mathrm{CH}_{2} \mathrm{CH}_{2} \mathrm{CH}_{2}\right) ; \delta_{\mathrm{C}}\left(75 \mathrm{MHz} ; \mathrm{CDCl}_{3}\right) 155.0(\mathrm{C}), 153.9(\mathrm{C}), 146.3$ $(\mathrm{CH}), 139.3(\mathrm{C}), 119.4(\mathrm{CH}), 32.9\left(\mathrm{CH}_{2}\right), 31.8\left(\mathrm{CH}_{2}\right), 24.8$ $\left(\mathrm{CH}_{2}\right) ; m / z(\mathrm{EI}) 236\left(\mathrm{M}^{+}, 65 \%\right), 235$ (100), 208 (2), 157 (10), 117 (30), 91 (22).

## 4,4'-Bi(benzo[c][2,7]naphthyridine) $\mathbf{2 5}$

A solution of the dimer $\mathbf{2 3}(44 \mathrm{mg}, 0.07 \mathrm{mmol})$ in toluene ( 2 ml ) at $-78{ }^{\circ} \mathrm{C}$ was treated with DIBAL-H $(0.1 \mathrm{ml}, 25 \%$ wt solution). The reaction mixture was allowed to warm to room temperature with stirring over 3 h . Upon completion the reaction mixture was diluted with water ( 5 ml ) and aqueous sodium hydroxide ( $1 \mathrm{ml}, 10 \%$ solution) and then extracted with toluene ( $3 \times 15 \mathrm{ml}$ ). The combined organic extracts were dried $\left(\mathrm{Na}_{2} \mathrm{SO}_{4}\right)$ and concentrated in vacuo to yield 5,5',6,6'-tetra-hydro-4,4'-bi(benzo $[c][2,7]$ naphthyridine) as an impure brown semi-solid ( $29 \mathrm{mg}, 97 \%$ ); $\delta_{\mathrm{H}}\left(400 \mathrm{MHz} ; \mathrm{CDCl}_{3}\right) 8.44(1 \mathrm{H}, \mathrm{d}$, $J 8.0, \mathrm{ArH}), 7.63(1 \mathrm{H}, \mathrm{d}, J 8.0, \mathrm{ArH}), 7.43(1 \mathrm{H}, \mathrm{d}, J 5.0, \mathrm{ArH})$, $7.14(1 \mathrm{H}, \mathrm{t}, J 8.0, \mathrm{ArH}), 6.77(1 \mathrm{H}, \mathrm{t}, J 8.0, \mathrm{ArH}), 6.56(1 \mathrm{H}, \mathrm{d}$, $J 8.0, \mathrm{ArH}), 4.23\left(2 \mathrm{H}, \mathrm{s}, \mathrm{CH}_{2}\right) ; \delta_{\mathrm{C}}\left(100 \mathrm{MHz} ; \mathrm{CDCl}_{3}\right) 147.5$ $(\mathrm{CH}), 145.3(\mathrm{C}), 131.1(\mathrm{CH}), 129.2$ (C), 128.1 (C), 126.6 (C), $124.4(\mathrm{CH}), 119.9(\mathrm{C}), 119.1(\mathrm{CH}), 116.1(\mathrm{CH}), 115.2(\mathrm{CH})$, $42.7\left(\mathrm{CH}_{2}\right)$.

A solution of the above compound ( $29 \mathrm{mg}, 0.07 \mathrm{mmol}$ ) in ethyl acetate ( 2 ml ) was treated with excess palladium on charcoal, with stirring for 48 h at $25^{\circ} \mathrm{C}$. The reaction mixture was filtered through a pad of Celite, and concentrated in vacuo to yield the title compound as a brown semi-solid ( $27 \mathrm{mg}, 97 \%$ ) (Found: $\mathrm{MH}^{+}$, 359.1296. $\mathrm{C}_{24} \mathrm{H}_{14} \mathrm{~N}_{4}+\mathrm{H}$ requires 359.1298); $v_{\text {max }}\left(\mathrm{CCl}_{4}\right) / \mathrm{cm}^{-1} 1642,762 ; \delta_{\mathrm{H}}\left(400 \mathrm{MHz} ; \mathrm{CDCl}_{3}\right) 9.45(2 \mathrm{H}, \mathrm{s}$, $\mathrm{ArH}), 9.26(2 \mathrm{H}, \mathrm{d}, J 8.0, \mathrm{ArH}), 8.64(2 \mathrm{H}, \mathrm{dd}, J 8.0,1.0, \mathrm{ArH})$, 8.54 ( $2 \mathrm{H}, \mathrm{dd}, J 8.0,1.0, \mathrm{ArH}$ ), 8.16 ( 2 H , dd, $J 8.0,1.0$, ArH), $7.87-7.71(4 \mathrm{H}, \mathrm{m}, \mathrm{ArH}) ; \delta_{\mathrm{C}}\left(100 \mathrm{MHz} ; \mathrm{CDCl}_{3}\right) 157.4(\mathrm{C}), 150.0$ $(\mathrm{CH}), 148.1(\mathrm{C}), 135.7(\mathrm{C}), 132.8(\mathrm{CH}), 129.2(\mathrm{CH}), 128.2(\mathrm{CH})$, 128.0 (C), $127.8(\mathrm{CH}), 126.3(\mathrm{CH}), 123.5(\mathrm{CH}), 120.8(\mathrm{C}) ;$ $\mathrm{m} / \mathrm{z}(\mathrm{CI}) 359\left(\mathrm{MH}^{+}, 100 \%\right)$.
