The Sugar Processing Research Institute, Inc. solicits nominations for the S.P.R.I. Science Award for 1996. This award, presented biennially, consists of a cash honorarium of U. S. \$1000, a plaque, and reasonable travel expenses to the award presentation at the S. P. R. I. Conference, to be held in New Orleans, Louisiana on April 14-18, 1996. The recipient is expected to deliver an address at the Conference.

Scientists/Researchers who have at least ten years of active research and development experience in sucrose science and technology, in a research environment of a university and/or research institute and/or company engaged in the business of sucrose processing and production, and have approximately ten recent, relevant sucrose and sucrose-related publications in internationally recognized textbooks, or journals which operate a referee system of selection for publication, are eligible for consideration by the Award Committee.
