Volume 101, Number 1 (1992), in the Letter to the Editor entitled "The Synthesis and Structure of a Beryllophosphate Crystal with an Open Framework," by Yu Long, pages 199-201: It has been brought to the Editors' attention that the tabulated bond distances and angles agree to within at least four significant figures with those published in an earlier paper by George A. Lager and C. V. Gibbs, "A Refinement of the Crystal Structure of Herderite, CaBe-PO₄OH," American Mineralogist 59, 919 (1974). The earlier research was carried out on a natural crystal whereas the later work was performed on synthetic material. The labeling of atoms and order of presentation of the tabulated material are substantially the same in the two publications; also the structural representations in the comparable figures differ only trivally. We regret that these similarities were not noticed during the normal review of Dr. Long's manuscript. Dr. Long has assured the Editors that his results were independently derived and that the various similarities are entirely coincidental.
