

145 New Members Added in 6 Months

AS of November 12, 1944, six months after adjournment of the spring meeting, the current Membership committee has had unprecedented success in bringing into the Society a number of eminently qualified persons from a wide variety of fatty oil pursuits and related endeavors.

In this first six-month period 145 new membership applications have been received and approved. This six months' growth is almost as great as the previous all-time annual membership record of the past fiscal year in which 158 new members were received into the Society. Unquestionably the previous all-time high membership record will be greatly exceeded at the end of the current fiscal year in May, 1945.
