

Oils and Fats in Canada to Be Discussed at Fall Meet; More Than 30 Other Papers

MORE than 30 papers in the oils and fats field have been promised for the 18th annual fall meeting of the American Oil Chemists' Society in Chicago on October 25-27, according to Dr. W. B. Hendrey, program chairman. Sessions will be held at the LaSalle hotel, and a dinner dance on Thursday evening, October 26, will be one of the chief social features.

F. H. Lehberg, deputy administrator of oils and fats for the Canadian government, will discuss the oil and fat situation in Canada from two points of view: commercial statistics and technical aspects. Paralleling his official point of view will be that of Dr. Donald D. Keyes, new director of the Office of Production Research and Development in Washington.

Other speakers will include Enrique Luaces, president of the Chemical Development Corporation; R. H. Anderson and D. M. Wheeler of General Mills; K. V. McCulloch and W. R. Catlow, Jr., of the Bakelite company; Prof. H. A. Schuette of the University of Wisconsin; William Ault of the Eastern Regional Research Laboratory; W. H. Goss and J. C. Cowan of the Northern Regional Research Laboratory; C. G. Harrell of the Pillsbury Flour Mills company; A. W. Weitkamp, Standard Oil company, Whiting, Ind.; W. D. Pohle, V. C. Mehlenbacher, and J. H. Cooke of Swift and Company; and George Huss, Curtiss Candy Company.

Symposia are planned on drying oils and soap. General topics will include composition of fats, analytical determinations, separation of fatty acids by liquid-liquid counter-current extraction, and stability of fats.
