## Vollertsen and Paquin Named Honorary Members

IN A SURPRISE move during the 38th annual meeting at New Orleans petitions were circulated to present the names of two distinguished men for election to honorary membership in the Society, and these were duly elected at the session on May 22, at which S. O. Sorensen presided: Felix Paquin and J. J. Vollertsen.

Mr. Paquin was a founder of the group known as the Society of Cottonseed Analysts which later became the American Oil

Chemists' Society and was president pro tem in 1909 and president in 1910. He is owner of the laboratory, Felix Paquin and Associates, in Galveston, Texas, and habitually attends all the annual meetings. He was invited to share the responsibilities of presiding at the afternoon session on May 20. The petition on his behalf read as follows:

"Mr. Paquin has rendered special service to the Society as its first president in 1910 and served as president pro tem during the year 1909, at which time the original steps in organization of the Society were taken."

Mr. Vollertsen has been a member of the Society since 1916, chairman of the Uniform Methods Committee since 1920 and chairman

since 1928, also chairman of the Smalley Foundation Committee since 1936, and member of the Journal Committee since 1932. He has also served as chairman of the Chicago convention committee for several years. In December 1946 he retired from his position as chief of chemical research development, Armour and Company, Chicago. The petition for him read as follows:

"As an expression of the high esteem with which Mr. John J. Vollertsen is held by the entire membership of the American Oil Chemists' Society and in recognition of his invaluable contributions to the growth and activities of the Society during his many years of faithful and continuous service, we the undersigned members of the Society hereby recommend that he be elected an honorary member of the Society for life."

## R. T. Milner Elected President of A.O.C.S. for 1947-48

R EID T. MILNER, head of the analytical and physical chemistry division of the Northern Regional Research Laboratory, Peoria, Ill., since 1941, was elected president of the American Oil Chemists' Society at the 38th annual meeting in New Orleans, La., on May 22, 1947. Dr. Milner succeeds S. O. Sorensen of the Archer-Daniels-Midland Company, Minneapolis. He is a graduate of the University of Illinois and
