H. J. Morrison Dies

H. MORRISON, president of the American Oil Chemists' Society in 1924, died on October 7, 1950 in Cincinnati, O., after having been in fairly good health until near the end.

It was during his administration that publication of the quarterly, Journal of Oil and Fat Industries, was firmly established as the first periodical of the Society. Prior to it Society contributions had been run as the Chemists' Section in the Cotton Oil Press from 1917 on. Mr. Morrison had assisted in the making of plans for the new Journal before he became president.

Other Society achievements followed. The Fat Analysis Committee, previously a committee of the American Chemical Society only, became a joint committee of the ACS and AOCS. The Detergents Committee was created as the first real expansion of the AOCS into the field of soap chemistry. The first plans were made by the Society for the regular publication of its official methods. According to A. S. Richardson, who has supplied biographical details, Mr. Morrison also had an active program for discontinuing committees which had outlived their usefulness.

Born in Cincinnati in 1866, Mr. Morrison attended Yale university and went to work for Procter and Gamble after graduation in 1887. He left in 1892 however to become vice president of the Lytle Safe and Lock Company, subsequently organizing with his brother, W. P. Morrison, the Arcanium Process Company. By 1897 he was induced to rejoin Procter and Gamble. In 1912 he was made chemical superintendent, a position he held until 1919, when he retired from active administrative responsibility to be special and consulting chemist. In 1921 he went back to administrative control but retained the title of special and consulting chemist. Two years after that he was again released from administrative responsibility. In 1935 he retired from the company.

A sketch of Mr. Morrison's career was published in the February 1947 issue of the Journal and reprinted later in the volume entitled "Presidents and Committees of the American Oil Chemists' Society," 1947.
