

Completing Program for May Meeting in New Orleans

FEATURE of the technical program to be given at the 42nd annual spring meeting of the American Oil Chemists' Society in New Orleans on May 1-3, 1951, will be a discussion of the bleaching and edible oils by A. D. Rich, Filtrol Corporation, Los Angeles. A general program of the chemistry and technology of vegetable oils is being prepared by T. H. Hopper, program chairman.

Headquarters will be the Roosevelt hotel. A total of 225 rooms are being held in various New Orleans hotels for Society members and guests, and reservations should be sent direct to A. F. Proxies Still Needed

The national headquarters staff is still collecting dues for 1951 and still collecting proxies on the proposed amendment to the constitution and by-laws. The latter would establish a new membership classification, emeritus. The amendment to the constitution must be approved by two-thirds of the entire active membership. The first request for proxies was sent out on December 8, 1950, and the second early in February.

Every active member who has not yet mailed his proxy to the Chicago office at 35 E. Wacker drive is urged to do so in order to record his vote on the proposed amendments.
