The first short course of the Society was held in 1948 at the University of Illinois on the subject of vegetable oils. This was followed by a course on edible oils in 1949, also at Illinois. The third course was given on drying oils at the University of Minnesota in 1950. Lectures for the 1949 and 1950 courses, in bound form, are available from the Society office in Chicago, for \$2 and \$3, respectively. These were published originally in the Journal.

Papers given at the 1952 short course will also be published in the Journal, some time this fall probably as a supplement to an issue. The plan is to make them available later in bound reprint form.
