JULY 27-31 are the big dates on the calendar of the American Oil Chemists' Society this summer as preparations are completed for the fifth short course, which is to be held at Texas A & M College,

the engineering aspects of oil seed processing, broken down into extraction, deodorizing, statistical methods and quality control, instrumentation, heat transfer, corrosion, and filtra-

The complete program was published in the June issue, beginning with the orientation lecture on extraction and oil processing methods by H. D. Fincher, Anderson, Clayton and Company, Houston, Tex.,
