

#### ASTM Meeting Hears 110 Papers

Featured by 36 technical sessions at which 110 technical papers covering various aspects of engineering materials were presented, the 1954 annual meeting of the American Society for Testing Materials was held June 13-19, 1954 at Chicago, Ill.

111. Seventy-two of the Society's technical committees reported at the meeting, with the result that 65 new specifications and tests were approved and revisions in 229 existing tentatives and standards were acted upon. A total of 109 specifications and tests that have been published previously as tentative were approved for reference to Society letter ballot for adoption as standard. All these new and revised standards will be published later in the year in the 1954 Supplement to the Book of ASTM Standards.
