## September Meeting Planned for Sherman Hotel, Chicago

ARLY ARRANGEMENTS, formulated at a planning meeting of the Chicago convention committee on May 28 at the Sherman hotel, indicate that the fall meeting of the American Oil Chemists' Society will follow the traditional pattern to some extent and will offer a few innovations. Dates are September 24–26, 1956, and co-chairmen are A. F. Kapecki, Wurster and Sanger Inc., and C. W. Hoerr, Armour and Company.

On Sunday, the 23rd, there will be a mixer for early arrivals, and on Monday evening the customary stag smoker will be abandoned in favor of a cocktail party, sponsored by Distillation Products Industries, after which the evening will be free. Tuesday evening will be devoted to the usual dinner and dance, with no speakers' table. Entertainment of a sparkling type will be provided.

Other discussion was given over to registration details and fees, exhibit charges, program possibilities, ladies' entertainment, etc. It was decided not to plan for any field trips.

The Governing Board, with T. H. Hopper presiding, will meet on Sunday, as will some of the administrative and technical committees. There will also be a business session of the Society during the convention.

## August 1 Is Deadline for Fatty Acid Entries

A ugust 1 has been set as the deadline for manuscripts to be submitted for the \$500 award competition established by the Fatty Acid Producers' Division of the Association of American Soap and Glycerine Producers Inc. and administered by the American Oil Chemists' Society. Announcement of the winner will be made at the fall meeting of the Society at the Sherman hotel, Chicago, Ill., September 24-26.

The award is to be given for work done in an educational institution in the United States or Canada while the individual

is a candidate for a degree (bachelor, master, doctor) or on the staff of an educational institution within one year after receipt of such a degree. Submission of a paper or thesis may take place within one year after receipt of such a degree. In respect to team authorship, at least one of the candidates must meet the requirement as set forth above, in which event the entire team shall be considered eligible for the award.

Wheeler, General Mills Inc., Minneapolis, Minn. Judges will be J. B. Brown, Ohio State University, Columbus; J. C. Cowan, Northern Regional Research Laboratory, Peoria, Ill.; and A. R. Baldwin, Cargill Inc., Minneapolis, Minn.
