

## Symposia and Entertainment Forecast for Spring Meeting

ARRANGEMENTS for the 48th Annual Meeting of the American Oil Chemists' Society are rapidly being crystallized, according to Ralph M. Persell, general chairman. The meeting will be held at the Roosevelt Hotel, New Orleans, La., April 29 to May 1, 1957, and will include a number of entertainment features as well as an outstandingly broad technical program.

These include "Fats in Nutrition and Health," scheduled for Tuesday morning, and "Unit Processes and Operations," scheduled for Wednesday morning. Frank Dollear and H. L. E. Vix, respectively, of the Program Committee are responsible for these symposia. In addition, tentative plans for the technical program provide for concurrent ses-

sions on Monday afternoon, Tuesday morning, and Wednesday morning.
