Election of officers, as determined by mail ballot in the meantime, will be announced in Memphis.

## Survey Safety Rules

7 IDE INTEREST in the question of safety in solvent-extraction plants was shown by A.O.C.S. members in a recent survey conducted by the Technical Safety Committee. A questionnaire on the subject of "Safety Rules" was submitted to 40 individual members, representing almost as many companies in the solvent-extraction field. Thirty-two questionnaires were returned, and the answers show that industry considers this subject an important one.

The Technical Safety Committee under Chairman A. E. MacGee has appointed a solvent extraction subcommittee under Paul Sheffer to study safety in the plant. A special sub-group under Norman Witte made the survey and reported to the Technical Safety Committee at the fall meeting in Cincinnati.

All of the plants covered in the survey had established safety rules, which are effectively brought to the employees' attention on bulletin boards or in booklet form. Additional questions concerning the use of work permits, passes for visitors, and nonsparking tools were tabulated for further study by the subcommittee. Many additional subjects for study by the committee were suggested by those returning the questionnaire.

# July 14-18 Will Be Dates of 1958 Short Course

HE 1958 SHORT COURSE on soaps and syndets (synthetic detergents) will be held at the Princeton Inn, ▲ Princeton, N. J., during the week of July 14, accord-ing to Foster Dee Snell, chairman, who is head of the Foster D. Snell Laboratories in New York. All of the meetings will be held in an air-conditioned room. The course



will be open to both men and women. The only scheduled meal for the students will be dinner, at which there will be a speaker. Announcement of the fee will be made in the February issue of the Journal.

Chairmen of the respective five days of the course will be W. A. Peterson, Colgate-Palmolive Company, Jersey City, N. J.; J. L. Hale, Swift and Company, Newark, N. J.; Donald Price, New York consultant; Morris Mattikow, Refining Uninc., New York; and Jay C. Harris, Monsanto Chemical Company, Dayton, O.

Subjects for the first day will include alkylate, fatty alcohols, sulfonation and sulfa-tion, theoretical and practical aspects. The dinner speaker

will discuss the changing scene of soaps and syndets. On the second day topics will be ethylene oxide conden-

sation, amine condensates, builders and other adjuncts of syndets, fluorescers; dinner topic will be syndets in sewage.

Wednesday subjects will include specialty syndet structures and types, specialty syndet structures application, glycerine production, and glycerine application. The evening speaker will cover the dermatological aspects of soaps and syndets.

For the fourth day tentative plans are for presentations on saponification stressing the newer methods, splitting of fatty acid, spray drying, and analytical application stress-ing the newer methods. The economics of soaps and syndets will be the dinner topic.

On Friday, the final day, topics will be textile uses, general detergency, evaluation in metal processing, and general properties.

The various short courses of the Society, which began in 1948, are directed by the Education Committee, of which K. F. Mattil, Swift and Company, Chicago, is chairman.
