

Foreword

In 1952 a short course on soaps and syndets was held at Rutgers University. In keeping with the times a short course on syndets and soaps was held at Princeton Inn, July 14–18, 1958. In the intervening years the sale of syndets has so far outstripped the

sale of soap that we now refer to the more important subject of syndets first.



The short course opened with registration and a gettogether Sunday evening. Thereafter there were four one-hour lectures in the morning each day under the charge of a day chairman. Monday through Thursday the afternoons
