McKinney Given Award

In recognition of achievements in research, a Superior Service Award has been conferred by the U. S. Department of Agriculture on L. L. McKinney (1947) of the Northern Regional Research Laboratory, Peoria, Ill. The citation was presented May 26 by Secretary of Agriculture Ezra Taft Benson during a special ceremony in Washington, D. C.



Mr. McKinney, assistant director at NRRRL and until recently leader of its protein research group, received the award for developing new commercial derivatives from vegetable proteins and for discovering what causes toxicity to arise in proteins during certain types of processing. By identifying, isolating, and synthesizing the toxic factor, he provided new chemical agents for medical research and information for processing agricultural products.
