A paper describing the determination of cis-trans isomerization in dehydrated castor oil derivatives, using gas-liquid chromatography, will be presented by J. W. Breakley of Victor Wolf Limited, Manchester, England. He will also discuss the alkali isomerization of methyl linoleate and compare the GLC method with infrared analysis.

H. Niewiadomski of the Polytechnical Institute of Gdank, Poland, will present a paper on the chlorophylls and carotenes of rapeseed oil.

The effect of wheat lipids in bread doughs will be described by a pioneer in wheat lipid research, J. B. M. Coppock of Spillers Limited, London, England.

PUBLICATION RIGHTS:

The American Oil Chemists' Society reserves first publication rights on all papers delivered at official AOCS Meetings. A release from the Journal Editor must be obtained by authors wishing to publish elsewhere. Submitting of a paper to another publication before scheduled oral presentation can cause cancellation. Please promptly inform the Journal Editor of other than routine publication plans.

ABSTRACTS:

Abstracts should be 100-300 words long. Utilize the space provided on the reverse side. Please submit ONE CARBON COPY on plain white paper, in addition to the form.

DELIVERY TIME:

The delivery time for the standard paper is 20 minutes, including brief discussion period.

DEADLINE:

Note the deadline for abstracts at bottom of reverse side of form. The program will be arranged immediately thereafter. Please mail your two copies of the abstract in time to allow its arrival before the deadine.

ACCEPTANCE:

The author will be contacted at the earliest possible date with regard to acceptance and scheduling of his paper.

EQUIPMENT AND FACILITIES:

Please advise the Program Chairman if you will require any equipment other than $3\frac{1}{4}$ " x 4" lantern slide projector, blackboard and chalk. The aforementioned items will be available without request.
