

E. A. Day Accepts Position with IFF

E. A. Day, Professor of Food Science and Technology, Oregon State University, has resigned his position effective November 30 to accept a position as Vice President, Director of Research and Development with International Flavors & Fragrances, Inc., New York City. International Flavors & Fragrances has plants and office facilities in 20 countries, with major laboratories located in the United States, Holland and France. Dr. Day will direct the flavor research in these laboratories.

Dr. Day joined the faculty of Oregon State University in 1958 and quickly established a flavor chemistry research program which has received international recognition. He was the first recipient of the Institute of Food Technologists Research Award in 1964 and received the 1965 Borden Award from the American

Chemical Society. He recently was selected as the 1965 recipient of the Basic Research Award sponsored by the Agricultural Research Foundation of the Oregon Agricultural Experiment Station at Oregon State University.

G. C. Mees of DPI Dies Suddenly

G. C. Mees (1951), President of the Distillation Products Industries Division of Eastman Kodak Company, died unexpectedly Oct. 28, 1965. He was 55.

He became formally associated with DPI in 1939, and later became vice-president in charge of sales at DPI and a member of its management committee. He was appointed president of the division and chairman of its Operations Committee in 1957.

Mr. Mees was a member of the American Chemical Society, the Rochester Chamber of Commerce, the Chemists' Club of New York City, and AOCS. A member of the National Vitamin Foundation, Inc., he served as chairman of the Foundation's executive committee, 1958-60, and chairman of the Board of Governors, 1960-62.
