## ASTM Forms New Subcommittee on Thermophysical Properties

A new Subcommittee on Thermophysical Properties was recently formed at ASTM headquarters in Philadelphia, PA, by Committee E-37 on Thermal Analysis of the American Society for Testing and Materials (ASTM).

The subcommittee, divided into two sections and ten task groups, is concerned with the development of standard methods of test and recommended practices for the measurement of basic thermophysical properties.

The Section on Thermodynamic Properties includes task groups on thermal expansion, energy content, thermochemical properties, surface tension, and thermomagnetic properties.

The Section on Transport Properties has task groups on thermal conductivity and diffusivity, thermal radiative properties, electrical conductivity, thermoelectric properties, and viscosity.

## ANSI Issues 1976 Catalog of Standards

The American National Standards Institute, America's federated national standards system, has issued its 1976 catalog of American National Standards and international standards.

The 192-page catalog lists more than 6,000 American National Standards and some 4,000 international standards and recommendations. The American National Standards are those approved by ANSI through November, 1975. The international standards and recommendations are those received by ANSI last year and in earlier years from the International Organization for Standardization (ISO), the International Electrotechnical Commission (IEC), and the International Commission on Rules for the Approval of Electrical Equipment (CEE). All publications listed in the

catalog are available from ANSI's Sales Department.

The standards deal with dimensions, ratings, terminology and symbols, test methods, and performance and safety specifications for materials, equipment, components, and products in some two dozen technical fields—among them chemical, construction, electrical and electronics, information systems, materials handling, mechanical, nuclear, petroleum products, photography and motion pictures, textiles, and welding.

The catalog also abstracts special publications on subjects such as metric conversion and consumer affairs that are of interest to those active in the field of standardization. It includes a 28 page index to the publications listed, with information on how to order them.
