

The plant, now under construction, includes meal grinding facilities to produce soy flour. Soybeans, safflower, rapeseed, and sesame can be processed by the new installation.... Witco dedicates new plant



Witco Chemical Corp. formally dedicated its new \$8 million diatomite processing plant at Quincy, WA, on Oct. 18, 1977.

The new plant will enable the firm to triple its production of its 15 different grades of diatomite filteraids, Witco said. Witco's older plant produces 30,000 tons of product per year; the new plant's capacity will be 65,000 tons per year. The plant, approximately 150 miles from Seattle, will employ 50 persons and use process diatomite ore mined in Grant County, Washington, about 19 miles away from the new plant. Witco's filter products are used in food processing of edible oils as well as in processing of corn, beet, and cane sweeteners. The products also are used in environmental control systems, swimming pool filter systems, and processing of materials for pharmaceutical, dry cleaning, agriculture, and petroleum industries.

Witco chairman William Wishnick said the new plant was designed to meet an anticipated accelerated demand for diatomite products.
