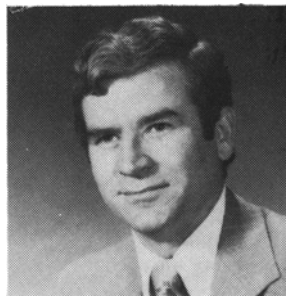
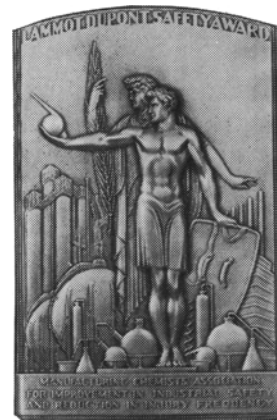

Donald H. 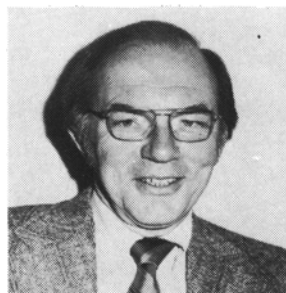
