
WORLD CONFERENCE ON SOAPS AND DETERGENTS CONVENTION CENTRE, MONTREUX, SWITZERLAND OCTOBER 9-14, 1977



reservations begin

Approximately four months from now, the World Conference on Soaps and Detergents will open in Montreux, Switzerland, featuring 51 technical papers on the latest practical technology from around the globe.

Planners were putting finishing touches on the program schedule during a committee session at the AOCS meeting in New York (held after the deadline for this report). Reservations for group travel flights from North America to Switzerland have begun to arrive at AOCS headquarters. Contracts for exhibit space have been received from soap and detergent manufacturers, equipment manufacturers, and suppliers in the United States and Europe. Registration forms will be received soon by thousands of potential registrants around the world.

The conference will run from Oct. 9 through Oct. 14, 1977. Technical papers will be presented during eight plenary session at the Montreux Convention Centre with simultaneous translation in French, English, and German. Talks will represent work that has not previously been published or presented elsewhere. Informal discussion groups at the end of each day's formal sessions will give, registrants a chance to converse with speakers.
