

The program for the AOCS Short Course on Processing and Quality Control of Fats and Oils has been completed by Program Chairman T.L. Mounts, with sixteen of the seventeen speakers selected.

The course is to be held June 25-29, 1978, in the Kellogg Center, Michigan State University, East Lansing, MI. The final registration fee has not been set, but probably will be approximately \$225, which will include a double-occupancy room; a Sunday evening mixer; all meals during the conference; morning and afternoon coffee breaks; and a copy of the proceedings of the short course.
